

# Senate Bill 5506

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Emergency Board for allocations during biennium.  
Appropriates moneys from General Fund to specified state agencies for biennial expenses.  
Declares emergency, effective July 1, 2023.

## A BILL FOR AN ACT

1 Relating to state financial administration; and declaring an emergency.

2 **Be It Enacted by the People of the State of Oregon:**

3 **SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri-**  
4 **ated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General**  
5 **Fund, the amount of \$50,000,000, for the purposes for which the Emergency Board lawfully**  
6 **may allocate funds.**

7 **SECTION 2. (1) In addition to and not in lieu of any other appropriation, there is appro-**  
8 **priated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General**  
9 **Fund, the amount of \$320,000,000, to be allocated to state agencies for state employee com-**  
10 **ensation changes.**

11 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**  
12 **by the Emergency Board prior to December 1, 2024, the moneys remaining on that date be-**  
13 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

14 **SECTION 3. (1) In addition to and not in lieu of any other appropriation, there is appro-**  
15 **priated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General**  
16 **Fund, the amount of \$130,000,000, to be allocated to state agencies for additional compen-**  
17 **sation changes.**

18 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**  
19 **by the Emergency Board prior to December 1, 2024, the moneys remaining on that date be-**  
20 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

21 **SECTION 4. (1) In addition to and not in lieu of any other appropriation, there is appro-**  
22 **priated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General**  
23 **Fund, the amount of \$65,000,000, to be allocated to state agencies for compensation changes**  
24 **driven by collective bargaining for workers who are not state employees.**

25 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**  
26 **by the Emergency Board prior to December 1, 2024, the moneys remaining on that date be-**  
27 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

28 **SECTION 5. (1) In addition to and not in lieu of any other appropriation, there is appro-**  
29 **priated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General**

1 Fund, the amount of \$40,000,000, to be allocated to the Public Defense Services Commission  
2 for pilot projects to address public defense services.

3 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated  
4 by the Emergency Board prior to December 1, 2024, the moneys remaining on that date be-  
5 come available for any purpose for which the Emergency Board lawfully may allocate funds.

6 **SECTION 6.** (1) In addition to and not in lieu of any other appropriation, there is appro-  
7 priated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General  
8 Fund, the amount of \$1,181,804, to be allocated to the Secretary of State for elections secu-  
9 rity and public education.

10 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated  
11 by the Emergency Board prior to December 1, 2024, the moneys remaining on that date be-  
12 come available for any purpose for which the Emergency Board lawfully may allocate funds.

13 **SECTION 7.** (1) In addition to and not in lieu of any other appropriation, there is appro-  
14 priated to the Emergency Board, for the biennium beginning July 1, 2023, out of the General  
15 Fund, the amount of \$600,097, to be allocated to the Secretary of State for elections over-  
16 sight.

17 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated  
18 by the Emergency Board prior to December 1, 2024, the moneys remaining on that date be-  
19 come available for any purpose for which the Emergency Board lawfully may allocate funds.

20 **SECTION 8.** This 2023 Act being necessary for the immediate preservation of the public  
21 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect  
22 July 1, 2023.
