

SENATE AMENDMENTS TO SENATE BILL 5514

1 On page 1 of the printed bill, delete lines 4 through 29 and delete page 2 and insert:

2 “**SECTION 1.** There are appropriated to the Department of Justice, for the biennium be-
3 ginning July 1, 2023, out of the General Fund, the following amounts, for the following pur-
4 poses:

16 “**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts
17 are established for the biennium beginning July 1, 2023, as the maximum limits for payment
18 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-
19 cluding lottery funds and federal funds, collected or received by the Department of Justice,
20 for the following purposes:

- 23 (2) Appellate Division \$ 30,223,753
- 24 (3) Civil Enforcement Division \$ 64,182,933
- 25 (4) Child Advocacy Division..... \$ 74,262,696

- 27 (6) Crime Victim and Survivor
- 28 Services Division..... \$ 29,619,429
- 29 (7) General Counsel Division..... \$ 88,967,293

32 “**SECTION 3.** Notwithstanding any other law limiting expenditures, the following amounts
33 are established for the biennium beginning July 1, 2023, as the maximum limits for payment
34 of expenses from federal funds collected or received by the Department of Justice for the
35 following purposes:

6 **“SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of
7 \$15,000,000 is established for the biennium beginning July 1, 2023, as the maximum limit for
8 payment of expenses by the Department of Justice, from American Rescue Plan Act
9 Coronavirus State Fiscal Recovery Fund moneys received by the Oregon Department of Ad-
10 ministrative Services and transferred to the Department of Justice, for crime victim and
11 survivor services, for community violence prevention grants.

12 **“SECTION 5.** This 2023 Act being necessary for the immediate preservation of the public
13 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
14 July 1, 2023.”.
