

Senate Bill 5530

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Department of State Police for certain biennial expenses.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from federal funds for certain purposes.

Limits biennial expenditures by department from certain moneys or other revenues allocated from Parks and Natural Resources Fund for certain purposes.

Declares emergency, effective July 1, 2023.

A BILL FOR AN ACT

Relating to the financial administration of the Department of State Police; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Department of State Police, for the biennium beginning July 1, 2023, out of the General Fund, the following amounts, for the following purposes:

- (1) **Patrol Services, Criminal Investigations and Gaming Enforcement \$232,060,380**
- (2) **Fish and Wildlife Enforcement \$ 12,295,645**
- (3) **Forensic Services and Chief Medical Examiner..... \$ 66,377,256**
- (4) **Administrative Services, Agency Support and Criminal Justice Information Services.... \$104,007,543**
- (5) **Debt Service..... \$ 21,294,737**

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Department of State Police, for the following purposes:

- (1) **Patrol Services, Criminal Investigations and Gaming Enforcement \$ 49,616,938**
- (2) **Fish and Wildlife**

7 **SECTION 3.** Notwithstanding any other law limiting expenditures, the following amounts
8 are established for the biennium beginning July 1, 2023, as the maximum limits for payment
9 of expenses from federal funds collected or received by the Department of State Police for
10 the following purposes:

19 **SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of
20 \$10,561,965 is established for the biennium beginning July 1, 2023, as the maximum limit for
21 payment of expenses from moneys allocated from the Parks and Natural Resources Fund to
22 the Department of State Police for fish and wildlife enforcement activities.

23 **SECTION 5.** This 2023 Act being necessary for the immediate preservation of the public
24 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
25 July 1, 2023.
