

Senate Bill 615

Sponsored by Senator GORSEK (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies crime of organizing speed racing event. Punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both. Punishes second and subsequent convictions within five-year period by maximum of five years' imprisonment, \$125,000 fine, or both.

Modifies crime of reckless driving to include activities related to speed racing.

Authorizes criminal forfeiture of instrumentalities of crime of reckless driving.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

2 Relating to vehicle speed racing; creating new provisions; amending ORS 131.602, 811.127 and
3 811.140; and prescribing an effective date.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 811.127 is amended to read:

6 811.127. *[(1) Except as provided in subsection (3) of this section, a person commits the offense of*
7 *organizing a speed racing event if the person in any manner organizes a speed racing event.]*

8 *[(2) As used in this section, "speed racing event" means an event that:]*

9 *[(a) Is preplanned and coordinated and involves two or more vehicles;]*

10 *[(b) Includes any of the activities described in ORS 811.125 (1); and]*

11 *[(c) Takes place on a highway.]*

12 **(1) Except as provided in subsection (2) of this section, a person commits the offense of**
13 **organizing a speed racing event if the person:**

14 **(a) Preplans or coordinates any activity described in ORS 811.125 or 811.140; or**

15 **(b) To facilitate or aid another individual who is participating in an activity described in**
16 **ORS 811.125 or 811.140:**

17 **(A) Obstructs or places a barricade on a highway; or**

18 **(B) Assists in placing an obstruction or barricade upon a highway.**

19 *[(3)]* **(2) A person who organizes a speed racing event is not in violation of this section if the**
20 **person has a permit from the road authority for the highway on which the event takes place.**

21 *[(4) The offense described in this section, organizing a speed racing event, is a Class C felony.]*

22 **(3) The offense described in this section, organizing a speed racing event, is:**

23 **(a) Except as provided in paragraph (b) of this subsection, a Class A misdemeanor.**

24 **(b) For a person's second or subsequent conviction within a five-year period preceding**
25 **the date of the person's current conviction, a Class C felony.**

26 **SECTION 2.** ORS 811.140 is amended to read:

27 811.140. (1) A person commits the offense of reckless driving if the person:

28 **(a) Recklessly drives a vehicle upon a highway or [other] premises **open to the public** [described**
29 **in this section] in a manner that endangers the safety of persons or property[.]; or**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **(b) Operates a vehicle on a highway or premises open to the public and, in the presence**
 2 **of two or more persons assembled for the purpose of spectating the conduct, intentionally:**

3 **(A) Breaks the traction of the vehicle’s rear tires;**

4 **(B) Spins the vehicle’s rear tires continuously by pressing the accelerator and increasing**
 5 **the engine speed; or**

6 **(C) Steers the vehicle in a manner designed to rotate the vehicle.**

7 *[(2) The use of the term “recklessly” in this section is as defined in ORS 161.085.]*

8 **(2) As used in this section, “intentionally” and “recklessly” have the meanings given**
 9 **those terms in ORS 161.085.**

10 (3) The offense described in this section, reckless driving, is a Class A misdemeanor *[and is ap-*
 11 *plicable upon any premises open to the public].*
