

Senate Bill 717

Sponsored by Senator GIROD (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes that decisions related to immunizations are personal health care decisions and that immunizations may not be mandated as condition of employment for registered nurses or other medical staff unless required by federal law.

Makes violation unlawful employment practice.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) It is the policy of the State of Oregon that decisions related to immu-**
6 **nizations are personal health care decisions and that immunizations may not be mandated**
7 **by an employer who employs registered nurses or other medical staff as a condition of em-**
8 **ployment unless required by federal law.**

9 **(2) It is an unlawful employment practice for an employer to require an applicant for**
10 **employment as a registered nurse or other medical staff or an employee who is employed as**
11 **a registered nurse or other medical staff to be immunized as a condition of future or con-**
12 **tinuing employment, unless the immunization is mandated by federal law.**

13 **(3) An applicant for employment or an employee who alleges a violation of this section**
14 **may file a complaint under ORS 659A.820.**

15 **(4) For purposes of this section:**

16 **(a) "Medical staff" includes those individuals licensed in this state under ORS chapter**
17 **677.**

18 **(b) "Registered nurse" means a nurse licensed under ORS 678.050.**

6 (11) In an action under subsection (1) or (9) of this section alleging a violation of ORS 659A.145
7 or 659A.421 or discrimination under federal housing law:

8 (a) "Aggrieved person" includes a person who believes that the person:

9 (A) Has been injured by an unlawful practice or discriminatory housing practice; or

10 (B) Will be injured by an unlawful practice or discriminatory housing practice that is about to
11 occur.

12 (b) An aggrieved person in regard to issues to be determined in an action may intervene as of
13 right in the action. The Attorney General may intervene in the action if the Attorney General cer-
14 tifies that the case is of general public importance. The court may allow an intervenor prevailing
15 party costs and reasonable attorney fees at trial and on appeal.
