A-Engrossed Senate Bill 889

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Modifies definition of "Class IV all-terrain vehicle."]

Modifies definitions of "Class I all-terrain vehicle" and "Class IV all-terrain vehicle." Removes requirement that certain off-road vehicles be equipped with windshield wipers when vehicle is operated off highway. Requires off-road vehicles operated on highway and equipped with windshield, top edge of which is at least six inches above steering wheel, to be equipped with windshield wiper.

- 2 Relating to off-road vehicles; creating new provisions; and amending ORS 801.190, 801.194 and 821.040.
- 4 Be It Enacted by the People of the State of Oregon:
- 5 **SECTION 1.** ORS 801.194 is amended to read:
- 801.194. (1) "Class III all-terrain vehicle" means a motorcycle that travels on two tires and that is actually being operated off highway.
 - (2) "Class IV all-terrain vehicle" means any motorized vehicle that:
- 9 (a) Travels on four or more **tires designed for off-road use only** [pneumatic tires that are six 10 inches or more in width and that are designed for use on wheels with a rim diameter of 14 inches or 11 less];
- 12 (b) Is designed for or capable of cross-country travel on or immediately over land, water, sand, 13 snow, ice, marsh, swampland or other natural terrain;
- 14 (c) Has nonstraddle seating;
- 15 (d) Has a steering wheel for steering control;
- 16 (e) Has a dry weight of [2,500] **3,500** pounds or less; [and]
- 17 (f) Is [80] **75** inches wide or less at its widest point; and
- 18 (g) Was originally manufactured for off-road use only.
- 19 **SECTION 2.** ORS 801.190 is amended to read:
- 20 801.190. "Class I all-terrain vehicle" means a motorized, off-highway recreational vehicle that:
- 21 (1) Is 50 inches or less in width;
- 22 (2) Has a dry weight of 1,200 pounds or less;
- 23 (3) Travels on three or more **tires designed for off-road use only** [pneumatic tires that are six 24 inches or more in width and that are designed for use on wheels with a rim diameter of 14 inches or 25 less];
 - (4) Uses handlebars for steering;

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

- (5) Has a seat designed to be straddled for the operator; and
- (6) Is designed for or capable of cross-country travel on or immediately over land, water, sand, snow, ice, marsh, swampland or other natural terrain.

SECTION 3. ORS 821.040 is amended to read:

- 821.040. (1) A person commits the offense of operation of an off-road vehicle without required equipment if the person is operating a vehicle described in ORS 821.010 in an area described in ORS 821.020 and the vehicle is not equipped in compliance with all of the following:
- (a) The vehicle must be equipped with a muffler that meets the standards for noise emissions established under ORS 821.030.
- (b) The vehicle must be equipped with brakes that meet the requirements established under ORS 821.030.
- [(c) The vehicle must be equipped with a windshield wiper if the vehicle is equipped with a windshield.]
- (c) When the vehicle is operated on a highway and the vehicle is equipped with a windshield, the top edge of which is at least six inches above the steering wheel, the vehicle must be equipped with a windshield wiper.
- (d) When the vehicle is operated off the highway and the vehicle is equipped with a windshield, the windshield must be unobstructed.
- [(d)] (e) When the vehicle is operated on sand, the vehicle must be equipped with a flag that meets the requirements established under ORS 821.030.
 - [(e)] (f) The vehicle must be equipped with any safety equipment required under ORS 821.030.
- [(f)] (g) At any time from one-half hour after sunset to one-half hour after sunrise, the vehicle must be equipped with and display headlights and taillights.
- (2) Motorcycles and mopeds are not required by this section to be equipped with windshield wipers.
- (3) The offense described in this section, operation of off-road vehicle without required equipment, is a Class C traffic violation.
- SECTION 4. The amendments to ORS 821.040 by section 3 of this 2023 Act apply to offenses committed on or after the effective date of this 2023 Act.
