Senate Bill 926

Sponsored by Senator KNOPP, Representative BREESE-IVERSON, Senator ANDERSON

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Prohibits merchant service company or financing agency from retaining funds that are property of merchant for more than 10 calendar days unless merchant service company or financing agency allows merchant access to funds, including ability to withdraw funds, or merchant service company or financing agency pays merchant statutory rate of interest on balance of funds retained.

Punishes violation of Act as unlawful practice under Unlawful Trade Practices Act.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

Relating to requirements for retaining merchant funds past a certain period of time; creating new 2

provisions; amending ORS 646.608; and prescribing an effective date.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** (1) As used in this section:

(a) "Financing agency" has the meaning given that term in ORS 72.1040. 6

7 (b) "Merchant" has the meaning given that term in ORS 72.1040.

8 (c) "Merchant service company" means a person that in the ordinary course of business 9 extends credit to or processes payments from or to a merchant.

(d) "Statutory rate of interest" means the rate of interest set forth in ORS 82.010 (1). 10

(2) A merchant service company or financing agency may not hold for more than 10 11 12 calendar days funds that are the property of a merchant with which the merchant service 13 company or financing agency has an agreement to extend credit or provide payment services unless the merchant service company or financing agency: 14

15(a) Allows the merchant access to the funds, including the ability to withdraw the funds from any account the merchant service company or financing agency maintains for the 16 merchant; or 17

(b) Pays, or credits to the account of, the merchant during each calendar day in which 18 19 the merchant service company or financing agency retains funds that are the property of the 20merchant an amount that is equivalent to the statutory rate of interest on the balance of the funds that the merchant service company or financing agency retains. 21

22(3) A merchant service company or financing agency that violates this section engages 23in an unlawful trade practice under ORS 646.608.

24**SECTION 2.** ORS 646.608 is amended to read:

25646.608. (1) A person engages in an unlawful practice if in the course of the person's business, 26 vocation or occupation the person does any of the following:

(a) Passes off real estate, goods or services as the real estate, goods or services of another.

- 28 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
- 29 proval, or certification of real estate, goods or services.

1 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-2 ciation with, or certification by, another.

3 (d) Uses deceptive representations or designations of geographic origin in connection with real
 4 estate, goods or services.

5 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics, 6 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have 7 or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the 8 person does not have.

9 (f) Represents that real estate or goods are original or new if the real estate or goods are de-10 teriorated, altered, reconditioned, reclaimed, used or secondhand.

(g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
or that real estate or goods are of a particular style or model, if the real estate, goods or services
are of another.

(h) Disparages the real estate, goods, services, property or business of a customer or anotherby false or misleading representations of fact.

(i) Advertises real estate, goods or services with intent not to provide the real estate, goods or
 services as advertised, or with intent not to supply reasonably expectable public demand, unless the
 advertisement discloses a limitation of quantity.

(j) Makes false or misleading representations of fact concerning the reasons for, existence of,or amounts of price reductions.

(k) Makes false or misleading representations concerning credit availability or the nature of the
 transaction or obligation incurred.

(L) Makes false or misleading representations relating to commissions or other compensation to
 be paid in exchange for permitting real estate, goods or services to be used for model or demon stration purposes or in exchange for submitting names of potential customers.

26 (m) Performs service on or dismantles any goods or real estate if the owner or apparent owner 27 of the goods or real estate does not authorize the service or dismantling.

(n) Solicits potential customers by telephone or door to door as a seller unless the person pro vides the information required under ORS 646.611.

(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
discount or other value is contingent upon an event occurring after the time the customer enters
into the transaction.

(p) Makes any false or misleading statement about a prize, contest or promotion used to publi cize a product, business or service.

(q) Promises to deliver real estate, goods or services within a certain period of time with intent
 not to deliver the real estate, goods or services as promised.

(r) Organizes or induces or attempts to induce membership in a pyramid club.

(s) Makes false or misleading representations of fact concerning the offering price of, or the
 person's cost for real estate, goods or services.

(t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
known material defect or material nonconformity.

(v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers, 1 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-2 ation. 3 (w) Manufactures mercury fever thermometers. 4 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal 5 law, or is: 6 (A) Prescribed by a person licensed under ORS chapter 677; and 7 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and 8 9 on the proper cleanup of mercury should breakage occur. (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta-33 34 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.

(3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose-35cuting attorney need not prove competition between the parties or actual confusion or misunder-36 37 standing.

38 (4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183 39 declaring the conduct to be unfair or deceptive in trade or commerce. 40

(5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or 41 suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attor-42 ney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney 43 fees. 44
