## PROPOSED AMENDMENTS TO HOUSE BILL 2572

On <u>page 1</u> of the printed bill, line 2, after "provisions;" delete the rest of the line and insert "amending ORS 131.602, 161.005 and 166.385; and repealing ORS 166.660.".

"(a) Publicly patrols, drills or engages in techniques capable of

 person without legal authority;

1 right to abstain; or

"(e) Trains to engage in any activity described in paragraphs (a) to
(d) of this subsection.

4 "(2) Unlawful paramilitary activity is a Class C felony.

5 **"(3) This section does not apply to:** 

"(a) The Armed Forces of the United States or the National Guard,
as those terms are defined in 10 U.S.C. 101, or any regularly organized
state militia or unorganized or reserve militia called into service by a
state or the United States, including a defense force authorized under
32 U.S.C. 109(c).

"(b) A group of individuals that associates as a military organization solely for historical purposes or fictional performances, or that parades in public as part of a bona fide veterans' organization, so long as the group does not carry or use ammunition or explosives.

15 "(c) Students in an education institution authorized by a state or 16 federal government to teach military science as a prescribed part of 17 the course of instruction, when under the supervision of a military 18 instructor.

"(d) Members of an organization that is authorized under state or federal law to provide paramilitary, law enforcement or security services training or to engage in paramilitary activity or the provision of law enforcement or security services, when performing the functions authorized by law and, in the case of paramilitary activity and law enforcement services, when under the direction and control of a governmental authority.

"(e) Troops of a foreign government operating under the authori zation or consent of the United States government.

28 "(f) Any lawful activity of the State Department of Fish and
29 Wildlife.

30 "(g) Any activity intended to teach or practice self-defense or self-

defense techniques, such as karate clubs or self-defense clinics, and
 similar lawful activity.

"(h) Any facility, program or lawful activity related to firearms in-3 struction and training intended to teach the safe handling and use of 4 firearms, or any other lawful sports or activities related to the indi- $\mathbf{5}$ vidual recreational use or possession of firearms, including but not 6 limited to hunting activities, target shooting, self-defense, firearms 7 collection or any organized activity, including but not limited to any 8 9 hunting club, rifle club, rifle range or shooting range, which does not include a conspiracy as defined in ORS 161.450 or the knowledge of or 10 the intent to cause or further acts of physical violence or damage to 11 persons or property. 12

"SECTION 2. (1)(a) If the Attorney General has reasonable cause
or believe that a person or group of persons has engaged in, or is about
to engage in, any conduct or act prohibited by section 1 of this 2023
Act, the Attorney General may bring a civil action in the name of the
State of Oregon for injunctive relief in the appropriate court.

"(b) The court may award reasonable attorney fees and costs of
investigation, preparation and litigation to the State of Oregon if the
State of Oregon prevails in an action under this subsection.

"(5) As used in this section, 'explosive' means a chemical com-3 pound, mixture or device that is commonly used or intended for the 4 purpose of producing a chemical reaction resulting in a substantially  $\mathbf{5}$ instantaneous release of gas and heat, including but not limited to 6 dynamite, blasting powder, nitroglycerin, blasting caps and nitrojelly, 7 but excluding fireworks as defined in ORS 480.111, black powder, 8 smokeless powder, small arms ammunition and small arms ammuni-9 tion primers. 10
