**PROPOSED AMENDMENTS TO
HOUSE BILL 3272**

1 On page 2 of the printed bill, delete lines 18 through 45 and insert:

2 **“SECTION 2.** ORS 56.185 is amended to read:

3 “56.185. (1) As used in this section:

4 “(a) ‘Local agency’ means every county, city, school district, municipal
5 organization, district or political subdivision, or any board, commission or
6 agency thereof, or any other local public agency.

7 “[*(b) ‘Small business’ means a prospective, new or established business with*
8 *100 or fewer employees that is or will be located in Oregon.*]

9 “[*(c)*] **(b)** ‘State agency’ means every state office, department, division,
10 bureau, board or commission or any other state agency.

11 “(2) The Secretary of State shall **collect from local agencies and state**
12 **agencies the information specified in subsection (3) of this section and**
13 **shall create and** maintain the Oregon License Directory as a searchable,
14 statewide database containing information regarding licenses, permits and
15 registrations for which **local agencies and state agencies impose** fees and
16 fee-related regulations [*are imposed on small businesses by local agencies and*
17 *state agencies in Oregon*] **on businesses in this state. Except as provided**
18 **in subsection (4) of this section,** the Secretary of State shall make the
19 Oregon License Directory available on the Internet to the public free of
20 charge.

21 “(3) All local agencies and state agencies that have functions related to

1 [the issuance of] **issuing** licenses, permits and registrations [for which] **and**
2 **that impose** fees and fee-related regulations [are imposed on small businesses
3 *must*] **on businesses in this state shall:**

4 “(a) **Collect and** report information in a manner [to be designated by] the
5 Secretary of State **specifies** by rule for inclusion in the Oregon License Di-
6 rectory, including but not limited to:

7 “(A) Information regarding the average time to process and issue licenses,
8 permits and registrations for which fees are imposed on [small] businesses
9 and the number of active licenses, permits and registrations; and

10 “(B) **The ethnicity, domicile, veteran status and street address or**
11 **electronic mail address of each owner and principal of a business that**
12 **applies for or renews a license, permit or registration; and**

13 “(b) Review and update the information required under paragraph (a) of
14 this subsection on or before July 1, but not later than September 1, of each
15 year.

16 “(4)(a) **The Secretary of State may not make the information that**
17 **local agencies and state agencies report under subsection (3)(a)(B) of**
18 **this section available or searchable on the Internet unless the person**
19 **to whom the information pertains has given explicit written consent**
20 **to make the information available and searchable.**

21 “(b) **The Secretary of State may share or communicate with or-**
22 **ganizations described in ORS 56.180 (2)(d), by electronic means or**
23 **otherwise, the information that local agencies and state agencies re-**
24 **port under subsection (3)(a)(B) of this section.**

25 “[4] (5) The Secretary of State may adopt rules necessary to implement
26 the provisions of this section.”.

27 On page 3, delete lines 1 through 11.
