## PROPOSED AMENDMENTS TO HOUSE BILL 3464

- On page 1 of the printed bill, delete lines 12 through 24 and insert:
- **"SECTION 1.** ORS 610.002 is amended to read:

- 4 "(1) 'Predatory animal' [or 'predatory animals' includes] means:
- 5 "(a) Feral swine as defined by State Department of Agriculture rule[,];

- 8 tive to agricultural crops, products [and] or activities[, but excluding game
- 9 birds and other birds determined by the State Fish and Wildlife Commission
- 10 to be in need of protection].
- "(2) 'Predatory animal' does not mean:
- 12 "(a) Game birds;
- 13 "(b) Nongame birds determined by the State Fish and Wildlife
- 14 Commission to be in need of protection; or
- 15 **"(c) Beavers."**.
- On page 3, line 1, delete "Whether, and under which conditions," and insert "Under which conditions".
- 18 After line 4, insert:
- 19 "(9) Notwithstanding any contrary prohibition by the commission under
- 20 subsection (1) of this section and any contrary rule adopted by the commis-
- sion under subsection (7) of this section, if a beaver imminently threatens

- infrastructure or agricultural crops, a person may take the beaver without
- 2 first obtaining a permit from the commission.
- 3 "(10) A person who takes a beaver pursuant to subsection (9) of this sec-
- 4 tion shall report the take as required by rules adopted by the commission
- 5 under subsection (7) of this section.
- 6 "(11) Rules adopted pursuant to subsection (7) of this section do not apply
- 7 to the take of a beaver on privately owned forestland, if the take is subject
- 8 to the provisions of section 22, 23 or 25, chapter 33, Oregon Laws 2022.".
- 9 In line 5, delete "(9)" and insert "(12)".
- 10 After line 6, insert:
- "(b) 'Forestland' has the meaning given that term in ORS 527.620.".
- In line 7, delete "(b)" and insert "(c)".
- In line 8, delete "(c)" and insert "(d)".
- 14 After line 11, insert:
- "SECTION 4. (1) The amendments to ORS 610.002 by section 1 of this
- 16 2023 Act become operative on the date the State Fish and Wildlife
- 17 Commission adopts the rules required under ORS 498.012 (7).
- 18 "(2) The commission shall notify the Legislative Counsel upon
- adoption of rules required under ORS 498.012 (7).".
