If this 2023 Act does not become effective until after April 15, 2023, this 2023 Act shall be operative retroactively to that date, and the operation and effect of ORS 244.050, as amended by section 1 of this 2023 Act, shall continue unaffected from April 15, 2023, to the effective date of this 2023 Act and thereafter. The Oregon Government Ethics Commission shall cause any civil penalty imposed under ORS 244.350 for failure to file the required statement of eco-

- 20 tion, shall provide training on the requirements of ORS 244.050, as
 - amended by section 3 of this 2023 Act, to members of district school
- 22 boards required to file a verified statement of economic interest after
- 23 January 1, 2026.
 - "SECTION 5. This 2023 Act being necessary for the immediate
- 25 preservation of the public peace, health and safety, an emergency is
- declared to exist, and this 2023 Act takes effect on its passage.".
