## PROPOSED AMENDMENTS TO HOUSE BILL 3333

- On page 1 of the printed bill, line 2, after the semicolon delete the rest of the line and line 3 and insert "and declaring an emergency.".
- Delete lines 5 through 27 and delete pages 2 through 6 and insert:
- "SECTION 1. The System of Care Advisory Council shall study the 4 application of a just culture model in the investigative processes of 5 child-caring agencies. The council shall submit reports of its findings 6 in the manner provided by ORS 192.245, and may include recommen-7 dations for legislation to implement any policy initiatives resulting 8 from the study, to the interim committees of the Legislative Assembly 9 related to human services. The first report is due no later than De-10 cember 1, 2023, and the second report is due no later than September 11 12 15, 2024.
