**PROPOSED AMENDMENTS TO  
B-ENGROSSED SENATE BILL 292**

1 On page 1 of the printed B-engrossed bill, line 2, after the second semi-  
2 colon delete the rest of the line and insert “and amending ORS 244.050.”.

3 On page 4, line 8, delete “4,000” and inset “1,650”.

4 In line 9, after “students” insert a period and delete the rest of the line  
5 and lines 10 and 11.

6 Delete lines 33 through 45 and delete pages 5 through 7.

7 On page 8, delete lines 1 through 5 and insert:

8 **“SECTION 2. ORS 244.050, as amended by section 1, chapter 66, Oregon  
9 Laws 2022, and section 1 of this 2023 Act, is amended to read:**

10 “244.050. (1) On or before April 15 of each year the following persons shall  
11 file with the Oregon Government Ethics Commission a verified statement of  
12 economic interest as required under this chapter:

13 “(a) The Governor, Secretary of State, State Treasurer, Attorney General,  
14 Commissioner of the Bureau of Labor and Industries, district attorneys and  
15 members of the Legislative Assembly.

16 “(b) Any judicial officer, including justices of the peace and municipal  
17 judges, except any pro tem judicial officer who does not otherwise serve as  
18 a judicial officer.

19 “(c) Any candidate for a public office designated in paragraph (a) or (b)  
20 of this subsection.

21 “(d) The Deputy Attorney General.

- 1       “(e) The Deputy Secretary of State.
- 2       “(f) The Legislative Administrator, the Legislative Counsel, the Legisla-  
3       tive Fiscal Officer, the Legislative Policy and Research Director, the Secre-  
4       tary of the Senate, the Chief Clerk of the House of Representatives and the  
5       Legislative Equity Officer.
- 6       “(g) The president and vice presidents, or their administrative equiv-  
7       alents, in each public university listed in ORS 352.002.
- 8       “(h) The following state officers:
- 9       “(A) Adjutant General.

- 11       “(C) Manager of State Accident Insurance Fund Corporation.
- 12       “(D) Water Resources Director.

8 and the auditor and executive officer thereof.

9       “(o) Each member of the board of directors of the State Accident Insur-  
10 ance Fund Corporation.

11       “(p) The chief administrative officer and the financial officer of each  
12 common and union high school district, education service district and com-  
13 munity college district.

14       “(q) Every member of the following state boards, commissions and coun-  
15 cils:

16       “(A) Governing board of the State Department of Geology and Mineral  
17 Industries.

18       “(B) Oregon Business Development Commission.

19       “(C) State Board of Education.

20       “(D) Environmental Quality Commission.

21       “(E) Fish and Wildlife Commission of the State of Oregon.

22       “(F) State Board of Forestry.

23       “(G) Oregon Government Ethics Commission.

24       “(H) Oregon Health Policy Board.

25       “(I) Oregon Investment Council.

26       “(J) Land Conservation and Development Commission.

27       “(K) Oregon Liquor and Cannabis Commission.

28       “(L) Oregon Short Term Fund Board.

29       “(M) State Marine Board.

30       “(N) Mass transit district boards.

- 28 “(u) Every member of a governing board of a public university listed in  
29 ORS 352.002.
- 30 “(v) Every member of the district school board of a common school dis-

1 trict or union high school district [*if the district has an average daily mem-*  
2 *bership, as defined in ORS 327.006, of 1,650 or more students*].

3 “(w) Every member of the board of directors of an authority created under  
4 ORS 465.600 to 465.621.

5 “(2) By April 15 next after the date an appointment takes effect, every  
6 appointed public official on a board or commission listed in subsection (1)  
7 of this section shall file with the Oregon Government Ethics Commission a  
8 statement of economic interest as required under ORS 244.060, 244.070 and  
9 244.090.

10 “(3) By April 15 next after the filing deadline for the primary election,  
11 each candidate described in subsection (1) of this section shall file with the  
12 commission a statement of economic interest as required under ORS 244.060,  
13 244.070 and 244.090.

14 “(4) Not later than the 40th day before the date of the statewide general  
15 election, each candidate described in subsection (1) of this section who will  
16 appear on the statewide general election ballot and who was not required to  
17 file a statement of economic interest under subsections (1) to (3) of this  
18 section shall file with the commission a statement of economic interest as  
19 required under ORS 244.060, 244.070 and 244.090.

20 “(5) Subsections (1) to (3) of this section apply only to persons who are  
21 incumbent, elected or appointed public officials as of April 15 and to persons  
22 who are candidates on April 15.

23 “(6) If a statement required to be filed under this section has not been  
24 received by the commission within five days after the date the statement is  
25 due, the commission shall notify the public official or candidate and give the  
26 public official or candidate not less than 15 days to comply with the re-  
27 quirements of this section. If the public official or candidate fails to comply  
28 by the date set by the commission, the commission may impose a civil pen-  
29 alty as provided in ORS 244.350.”.

30 In line 6, delete “4” and insert “3” and delete “3” and insert “2”.

1 In line 10, delete “3” and insert “2”.

2 Delete lines 13 through 15.
