**PROPOSED AMENDMENTS TO RESOLVE CONFLICTS TO
A-ENGROSSED SENATE BILL 406**

1 On page 4 of the printed A-engrossed bill, after line 26, insert:

2 **“SECTION 4a. If House Bill 2889 becomes law, section 4 of this 2023**
3 **Act (amending section 1, chapter 13, Oregon Laws 2023 (Enrolled House**
4 **Bill 2001)) is repealed and section 1, chapter 13, Oregon Laws 2023**
5 **(Enrolled House Bill 2001), as amended by section 1, chapter __,**
6 **Oregon Laws 2023 (Enrolled House Bill 2889), is amended to read:**

7 **“Sec. 1. (1)** There is established within the Oregon Department of Ad-
8 ministrative Services the Oregon Housing Needs Analysis. The purposes of
9 the Oregon Housing Needs Analysis are to further the:

10 “(a) Production of housing to meet the need of Oregonians at all levels
11 of affordability; and

12 “(b) Production of housing in a way that creates more housing choice by
13 affirmatively furthering fair housing, as defined in ORS 197.290.

14 “(2) The Oregon Housing Needs Analysis consists of three components as
15 follows:

16 “(a) The annual statewide housing analysis under section 2 (1), chapter
17 13, Oregon Laws 2023 (Enrolled House Bill 2001);

18 “(b) The allocated housing need under section 2 (2), chapter 13, Oregon
19 Laws 2023 (Enrolled House Bill 2001); and

20 “(c) The housing production targets under section 3, chapter 13, Oregon
21 Laws 2023 (Enrolled House Bill 2001).

1 “(3) Actions taken by the department under sections 1 to 3, chapter 13,
2 Oregon Laws 2023 (Enrolled House Bill 2001), are not subject to ORS 197.180
3 and are not land use decisions.

4 “(4) The Department of Land Conservation and Development and the
5 Housing and Community Services Department:

6 “(a) Shall assist the Oregon Department of Administrative Services with
7 its duties under sections 1 to 3, chapter 13, Oregon Laws 2023 (Enrolled
8 House Bill 2001).

9 “(b) May study and recommend methodological changes to the Oregon
10 Department of Administrative Services to improve the Oregon Housing Needs
11 Analysis’ functions and suitability for its purposes under subsection (1) of
12 this section. The departments shall solicit written and oral public testimony
13 to inform their recommendations.

14 “(5) As used in sections 1 to 3, chapter 13, Oregon Laws 2023 (Enrolled
15 House Bill 2001), ‘city’ or ‘city with a population of 10,000 or greater’ in-
16 cludes **cities, as defined in ORS 197.286, and** urban unincorporated com-
17 munities in Metro, as defined in ORS 197.015.”.

18 After line 45, insert:

19 **“SECTION 5a. If House Bill 2889 becomes law, section 5 of this 2023**
20 **Act (amending section 4, chapter 13, Oregon Laws 2023 (Enrolled House**
21 **Bill 2001)) is repealed.”.**
