**PROPOSED AMENDMENTS TO  
HOUSE BILL 2099**

1 In line 2 of the printed bill, after “transportation” insert “; creating new  
2 provisions; amending ORS 87.152, 153.083, 184.742, 319.520, 319.530, 319.550,  
3 366.805, 367.081, 646A.090, 802.031, 802.600, 803.102, 803.120, 803.212, 803.530,  
4 803.552, 805.103, 805.210, 805.250, 807.080, 807.220, 807.230, 807.310, 809.520,  
5 819.482, 820.110, 822.015, 822.020, 822.025, 822.027, 822.030, 822.033, 822.035,  
6 822.040, 822.045, 822.050, 822.060, 822.310, 822.315, 822.515, 822.700 and 822.990;  
7 repealing ORS 805.117, 805.242, 822.505, 822.510, 822.520, 822.525, 822.530 and  
8 822.535; and prescribing an effective date”.

**“SAFE ROUTES TO SCHOOL**

12

13 **“SECTION 1.** ORS 184.742 is amended to read:

14 “184.742. (1) The Oregon Transportation Commission may provide match-  
15 ing grants under this section for safety improvement projects near schools.

16 “(2) To qualify for a matching grant an applicant shall:

17 “(a) Demonstrate that a project fits within the applicable plan developed  
18 pursuant to ORS 195.115;

19 “(b) Provide a cash match of at least 40 percent of the project’s costs; and

20 “(c) Provide any other information required by the commission.

21 “(3) Notwithstanding subsection (2) of this section, **by rule**, the commis-

1 sion may reduce the amount the applicant must provide for a cash match.  
2 *[An applicant providing a reduced cash match shall provide at least 20 percent*  
3 *of the project’s costs. This subsection applies if:]*

4 “*[(a) The school is located in a city with a population of 5,000 or fewer;]*

5 “*[(b) The project reduces hazards within a safety corridor, as defined by*  
6 *the commission by rule; or]*

7 “*[(c) The school site qualifies for assistance under Chapter I of Title I of*  
8 *the federal Elementary and Secondary Education Act of 1965.]*

9 “(4) The commission shall prioritize the expenditure of funds as author-  
10 ized under this section for projects that are located within a [*one-mile*]  
11 **two-mile** radius of a school that serves students in prekindergarten,  
12 kindergarten or grades 1 through [8] **12**, or any combination of those grade  
13 levels[, *or a school that serves students in kindergarten through grade 12*].

14 “(5) The matching grants shall be used to reduce barriers and hazards to  
15 children walking or bicycling to and from school, including but not limited  
16 to safety improvement projects that:

17 “(a) Improve sidewalks;

18 “(b) Reduce vehicle speeds;

19 “(c) Improve pedestrian and bicycle crossings; or

20 “(d) Create or improve bicycle lanes.

21 “(6) The commission may adopt rules specifying the application process  
22 and the selection criteria that will be used in awarding matching grants.

24 “**CONNECT OREGON**

25

26 “**SECTION 2.** ORS 367.081 is amended to read:

27 “367.081. (1) Each biennium, the Department of Transportation may pro-  
28 vide grants for transportation projects under ORS 367.080 only if the de-  
29 partment determines that \$50 million or more will be available in the  
30 Connect Oregon Fund for [*the biennium in which the grants are provided*]

1 **grants awarded under ORS 367.080 to 367.086.**

2 “(2) The department may use up to one percent of the amounts available  
3 within the Connect Oregon Fund to pay administrative costs incurred by the  
4 department in carrying out the provisions of ORS 367.080 to 367.086.

5 “(3) Each biennium, the department shall transfer seven percent of the  
6 moneys in the Connect Oregon Fund to the Multimodal Active Transporta-  
7 tion Fund established under ORS 367.091 for the purpose of providing grants  
8 for bicycle and pedestrian transportation projects.

9  
10 **“USE FUEL**

11  
12 **“SECTION 3.** ORS 319.550 is amended to read:

13 “319.550. (1) Except as provided in this section, a person may not use fuel  
14 in a motor vehicle in this state unless the person holds a valid user’s license.

15 “(2) A nonresident may use fuel in a motor vehicle not registered in  
16 Oregon for a period not exceeding 30 **consecutive** days without obtaining a  
17 user’s license or the emblem issued under ORS 319.600, if, for all fuel used  
18 in a motor vehicle in this state, the nonresident pays to a seller, at the time  
19 of the sale, the tax provided in ORS 319.530.

20 “(3) A user’s license is not required for a person who uses fuel in a motor  
21 vehicle [*with a combined weight of 26,000 pounds or less*] if, for all fuel used  
22 in a motor vehicle in this state, the person pays to a seller, at the time of  
23 the sale, the tax provided in ORS 319.530.

24 **“(4) A user’s license is not required for a person who is subject to**  
25 **the weight-mile tax described in ORS 825.474 and 825.476 or the flat fee**  
26 **rate described in ORS 825.480.**

27 “[~~(4)(a)~~] **(5)(a)** A user’s license is not required for a person who uses fuel  
28 as described in ORS 319.520 (7) in the vehicles specified in this subsection  
29 if the person pays to a seller, at the time of the sale, the tax provided in  
30 ORS 319.530.

1 “(b) Paragraph (a) of this subsection applies to the following vehicles:

2 “(A) Motor homes as defined in ORS 801.350.

3 “(B) Recreational vehicles as defined in ORS 174.101.

4 “[5] (6) A user’s license is not required for a person who uses fuel in a  
5 motor vehicle:

6 “(a) Metered use by which is subject to the per-mile road usage charge  
7 imposed under ORS 319.885; and

8 “(b) That also uses fuels subject to ORS 319.510 to 319.880.

9 “[6] (7) A user’s license is not required for a person who uses fuel in a  
10 motor vehicle on which an emblem issued for the motor vehicle pursuant to  
11 ORS 319.535 is displayed.

12 **“SECTION 4.** ORS 319.520 is amended to read:

13 “319.520. As used in ORS 319.510 to 319.880, unless the context clearly  
14 indicates a different meaning:

15 “(1) ‘Cardlock card’ means a fuel card:

16 “(a) Capable of generating an electronic invoice or electronic statement  
17 that includes the information required by ORS 319.671 and the applicable fuel  
18 tax amount;

19 “(b) Issued for a specific vehicle, a specific piece of equipment or a group  
20 of equipment;

21 “(c) That includes the qualifying information, as designated by the De-  
22 partment of Transportation by rule, that is printed on the electronic invoice  
23 or electronic statement;

24 “(d) That allows the tax status of the cardlock card to be indicated on the  
25 electronic invoice or electronic statement and includes state tax as a sepa-  
26 rate item on the invoice or statement; and

27 “(e) That allows a cardlock card issuer to generate a statement recording,  
28 by fuel type, gallons of fuel purchased for domestic and foreign customers  
29 each month.

30 “(2) ‘Combined weight’ means the total empty weight of all vehicles in a

1 combination plus the total weight of the load carried on that combination  
2 of vehicles.

3 “(3) ‘Delinquent’ means having failed to pay a tax or penalty within the  
4 time provided by law.

5 “(4) ‘Department’ means the Department of Transportation.

6 “(5) ‘Domestic customer’ means a customer making a purchase at a  
7 nonretail facility owned by the cardlock card issuer.

8 “(6) ‘Foreign customer’ means a customer making a purchase at a  
9 nonretail facility owned by a seller other than the cardlock card issuer.

10 “(7) ‘Fuel’ means any combustible gas, liquid or material of a kind used  
11 for the generation of power to propel a motor vehicle on the highways except  
12 motor vehicle fuel as defined in ORS 319.010.

13 “(8) ‘Highway’ means every way, thoroughfare and place, of whatever  
14 nature, open to the use of the public for the purpose of vehicular travel.

15 “(9) ‘Light weight’ means the weight of a vehicle when fully equipped for  
16 moving over the highway.

17 “(10) **‘Liquefied petroleum gas’ includes propane, pentane and any**  
18 **mixture of propane and pentane.**

19 “[10] (11) ‘Motor vehicle’ means every self-propelled vehicle operated on  
20 the highway, except an implement of husbandry used in agricultural oper-  
21 ations and only incidentally operated or moved upon the highway.

22 “[11] (12) ‘Nonretail facility’ means:

23 “(a) An unattended facility accessible only by cardlock card and not as-  
24 sociated with a retail facility; or

25 “(b) An unattended portion of a retail facility separate from the retail  
26 operations and accessible only by cardlock card.

27 “[12] (13) ‘Person’ means any individual, firm, copartnership, joint ven-  
28 ture, association, corporation, trust, receiver or any group or combination  
29 acting as a unit.

30 “[13] (14) ‘Seller’ means:

1 “(a) A person that sells fuel to a user; or

2 “(b) If the fuel is dispensed at a nonretail facility, the person that owns  
3 the user’s accounts and bills the user for fuel purchased at a nonretail fa-  
4 cility.

5 “[~~(14)~~] **(15)** ‘To sell fuel for use in a motor vehicle’ means to dispense or  
6 place fuel for a price into a receptacle on a motor vehicle, from which re-  
7 ceptacle the fuel is supplied to propel the motor vehicle.

8 “[~~(15)~~] **(16)** ‘To use fuel in a motor vehicle’ means to receive into any re-  
9 ceptacle on a motor vehicle, fuel to be consumed in propelling the motor  
10 vehicle on the highways of this state; and, if the fuel is received into the  
11 receptacle outside the taxing jurisdiction of the state, ‘to use fuel in a motor  
12 vehicle’ means to consume in propelling the motor vehicle on the highways  
13 of this state.

14 **“SECTION 5.** ORS 319.530 is amended to read:

15 “319.530. (1) To compensate this state partially for the use of its highways,  
16 an excise tax hereby is imposed at the rate of 34 cents per gallon on the use  
17 of fuel in a motor vehicle.

18 “(2) Except as otherwise provided in subsections (3) [~~and (4)~~] **to (6)** of this  
19 section, 100 cubic feet of fuel used or sold in a gaseous state, measured at  
20 14.73 pounds per square inch of pressure at 60 degrees Fahrenheit, is taxable  
21 at the same rate as a gallon of liquid fuel.

22 “(3) [~~One hundred twenty~~] **123.57** cubic feet, **or 5.66 pounds**, of com-  
23 pressed natural gas used or sold in a gaseous state[, *measured at 14.73 pounds*  
24 *per square inch of pressure at 60 degrees Fahrenheit,*] is taxable at the same  
25 rate as [*a gallon of liquid fuel*] **one gasoline gallon.**

26 “[~~(4)~~] *One and three-tenths liquid gallons of propane at 60 degrees*  
27 *Fahrenheit is taxable at the same rate as a gallon of other liquid fuel.*]

28 “(4) **1.353 gallons, or 5.75 pounds, of liquefied petroleum gas is tax-**  
29 **able at the same rate as one gasoline gallon.**

30 “(5) **1.71 gallons, or 6.059 pounds, of liquefied natural gas is taxable**

1 at the same rate as one diesel gallon.

2 “(6) One kilogram of hydrogen is taxable at the same rate as one  
3 gasoline gallon.

4  
5 “SMALL CITY ALLOCATION

6  
7 “SECTION 6. ORS 366.805 is amended to read:

8 “366.805. (1) Except as provided in subsection (2) of this section, the ap-  
9 propriation specified in ORS 366.800 shall be allocated to the cities as pro-  
10 vided in this subsection. The moneys subject to allocation under this  
11 subsection shall be distributed by the Department of Transportation accord-  
12 ing to the following:

13 “(a) The moneys shall be distributed to all the cities.

14 “(b) Each city shall receive such share of the moneys as its population  
15 bears to the total population of the cities.

16 “(2) Each year, the sum of \$2,500,000 shall be withdrawn from the appro-  
17 priation specified in ORS 366.800 and \$2,500,000 shall be withdrawn from  
18 moneys available to the Department of Transportation from the State High-  
19 way Fund. The sums withdrawn shall be transferred to a separate account  
20 to be administered by the Department of Transportation. The following apply  
21 to the account described in this subsection:

22 “(a) Money from the account shall be used only [*upon streets*] **on roads:**

23 “(A) That are not a part of the state highway system, **with the exception**  
24 **of project elements that are required to comply with federal or state**  
25 **law;**

26 “(B) That are within cities with populations of 5,000 or fewer persons; and

27 “(C) That are inadequate for the capacity the [*streets serve*] **roads serve**  
28 or are in a condition detrimental to safety.

29 “(b) **To the extent moneys are available to fund whole projects,** all  
30 moneys in the account shall be [*allotted*] **allocated** each year.

1 “(c) Subject to paragraph (d) of this subsection, the department shall de-  
2 termine [*the distribution of the expenditures after considering applications*  
3 *from the cities submitted to the department*] **annual allocation after con-**  
4 **sidering applications, including project budgets, submitted by the**  
5 **cities to the department.**

6 “(d) The department may enter into agreements with cities upon the ad-  
7 vice and counsel of **the small city advisory committee to determine al-**  
8 **location based on those applications** [*organizations representing cities to*  
9 *establish:*]

10 “[*(A) The method of allotting moneys from the account; or*]

11 “[*(B) The method of considering applications from cities and determining*  
12 *distribution based on the applications*].

13 “(3) The Director of Transportation shall establish a small city advisory  
14 committee. The **small city** advisory committee shall review **department**  
15 **recommendations and approve** applications submitted by small cities [*and*  
16 *shall recommend applications for approval*] to the director. In consultation  
17 with the League of Oregon Cities, the director shall appoint to the **small**  
18 **city** advisory committee one representative of a small city in each of the five  
19 regions of this state.

20 “(4) For purposes of this section:

21 “(a) Region one consists of Clackamas, Hood River, Multnomah and  
22 Washington Counties.

23 “(b) Region two consists of Benton, Clatsop, Columbia, Lane, Lincoln,  
24 Linn, Marion, Polk, Tillamook and Yamhill Counties.

25 “(c) Region three consists of Coos, Curry, Douglas, Jackson and Josephine  
26 Counties.

27 “(d) Region four consists of Crook, Deschutes, Gilliam, Jefferson,  
28 Klamath, Lake, Sherman, Wasco and Wheeler Counties.

29 “(e) Region five consists of Baker, Grant, Harney, Malheur, Morrow,  
30 Umatilla, Union and Wallowa Counties.





1 *erate a motor vehicle under ORS 807.070 for an applicant who is certified by*  
2 *the holder of a driver competency testing certificate as competent to exercise*  
3 *the driving privileges in the class of license or in the endorsement sought by*  
4 *the applicant.]*

5 *“(4) The rules adopted by the department under this section may establish*  
6 *reasonable fees for the issuance of a certificate or as part of any program of*  
7 *regulating certificate holders that is established by the department.]*

8 *“(5) When adopting rules under this section, the department may:]*

9 *“(a) Make the certificate renewable upon any basis determined convenient*  
10 *by the department and may include provisions for cancellation, revocation or*  
11 *suspension of certificates or for probation of certificate holders.]*

12 *“(b) Provide for the issuance of certifications allowing the holder to certify*  
13 *competency in several classes or types of driving privileges or limiting the*  
14 *classes or types of driving privileges for which the holder may certify compe-*  
15 *tency.]*

16 *“(c) Establish the forms of certificates to be issued.]*

17 *“(d) Establish and require forms that are to be used by certificate holders*  
18 *in certifying competency.]*

19 *“(e) Establish any qualifications or requirements for obtaining a certificate*  
20 *that the department determines necessary to protect the interests of persons*  
21 *seeking certification by certificate holders.]*

22 *“(f) Issue certificates to publicly owned and operated educational facilities*  
23 *to allow programs for certification of competency.]*

24 *“(g) Issue certificates to employers to allow the employers to establish*  
25 *programs primarily for the certification of employees’ competency. The depart-*  
26 *ment may provide that programs established under this paragraph may be op-*  
27 *erated without driver training school certificates under ORS 822.500 and*  
28 *without driver training instructor certificates under ORS 822.525.]*

29 *“(h) Establish any other provisions or requirements necessary to carry out*  
30 *the purposes of this section.]*

1       **“(1) The Department of Transportation may adopt rules and enter**  
2 **into contracts necessary for the regulation and certification of persons**  
3 **and organizations authorized to certify an individual’s competency to**  
4 **safely operate a motor vehicle, including a commercial motor vehicle,**  
5 **on behalf of the department.**

6       **“(2) Rules adopted under this section may include, but are not**  
7 **limited to, the following:**

8       **“(a) Establishing methods and procedures for the testing of com-**  
9 **petency to operate different types of motor vehicles.**

10       **“(b) Establishing the manner and mechanism by which test results**  
11 **shall be sent to the department.**

12       **“(c) Establishing reasonable fees as part of any program for regu-**  
13 **lation created by the department under this section.**

14       **“(d) Establishing grounds for suspension, cancellation or revocation**  
15 **of a person’s or organization’s authorization to certify competency to**  
16 **operate motor vehicles.**

17       **“(e) Establishing requirements for records retention.**

18       **“(f) Establishing requirements for inspections of premises, investi-**  
19 **gations and monitoring, including covert monitoring, to ensure that**  
20 **testing is conducted in strict accord with rules adopted under this**  
21 **section.**

22       **“(g) Establishing bond and insurance requirements.**

23       **“(3) In adopting rules under this section, the department shall take**  
24 **into consideration the regulations and laws of the federal government.**

25       **“SECTION 10. ORS 807.220 is amended to read:**

26       **“807.220. (1) The Department of Transportation shall provide for the is-**  
27 **suance of emergency driver permits in a manner consistent with this section.**

28       **“(2) Except as otherwise provided in this section an emergency driver**  
29 **permit is subject to the fees, provisions, conditions, prohibitions and penal-**  
30 **ties applicable to a Class C driver license.**

1       “(3) The following apply to an emergency driver permit:

2       “(a) The department may issue an emergency driver permit to a person  
3 14 years of age or older.

4       “(b) The department shall place restrictions on the permit that designate  
5 the routes over which the permit is valid. The department shall designate  
6 routes it determines necessary from the facts creating the emergency.

7       “(c) The permit shall only be issued if the department is satisfied that an  
8 emergency exists that requires operation of a motor vehicle by the applicant.

9       “(d) The department may establish a form for the permit that differs from  
10 the form required for a license.

11       “(e) The only fee required for issuance of the permit is the emergency  
12 driver permit fee under ORS 807.370.

13       “(f) The department may establish a period for the expiration of the per-  
14 mit that coincides with the end of the emergency that is the basis for the  
15 permit.

16       “(g) The department shall cancel the permit if the department determines  
17 that the holder of the permit has operated a motor vehicle over any highway  
18 or for any purpose other than one approved under the permit.

19       “(h) If an emergency driver permit is canceled, the person issued the  
20 permit is ineligible to be issued another emergency driver permit for a period  
21 of one year.

22       “(i) In addition to any other application requirements for the emergency  
23 driver permit, the applicant must obtain the [*endorsement on the*  
24 *application*] **approval** of the sheriff of the county in which the applicant re-  
25 sides.

26       “(4) The department may issue an emergency driver permit, if the person  
27 qualifies for the permit, to a person whose driving privileges are suspended  
28 under ORS 809.280 because the department has received an order suspending  
29 driving privileges under ORS 809.260. In addition to other emergencies, a  
30 situation that leaves the applicant with no alternative means to travel to

1 and from school is an emergency for purposes of a permit issued under this  
2 subsection.

3 **“SECTION 11.** ORS 807.230 is amended to read:

4 “807.230. The Department of Transportation shall provide for issuance of  
5 special student driver permits in a manner consistent with this section. A  
6 special student driver permit grants the driving privileges provided in this  
7 section or under the permit. Except as otherwise provided in this section,  
8 a special student driver permit is subject to the fees, provisions, conditions,  
9 prohibitions and penalties applicable to a Class C **driver** license. The fol-  
10 lowing apply to a special student driver permit:

11 “(1) The department may issue a special student driver permit to a person  
12 14 years of age or older.

13 “(2) The department shall place restrictions on the permit to limit opera-  
14 tion of a vehicle under the permit to operation necessary as a means of  
15 transportation to or from the school, college or other educational institution  
16 attended by the person to whom the driver permit is issued.

17 “(3) The permit shall only be issued if the applicant has no other avail-  
18 able means of transportation by which to continue the applicant’s education.

19 “(4) The permit shall only be issued if the department is satisfied that the  
20 applicant has had sufficient experience in the operation of motor vehicles to  
21 operate a motor vehicle without endangering the safety of the public.

22 “(5) The department may establish a form for the permit that differs from  
23 the form required for a license that is issued.

24 “(6) The only fee required for issuance of the permit is the special student  
25 driver permit fee under ORS 807.370.

26 “(7) The department shall cancel the permit if the department determines  
27 that the holder of the permit has operated a motor vehicle over any highway  
28 or for any purpose other than as approved under the permit.

29 “(8) If a special student driver permit is canceled, the person issued the  
30 permit is ineligible to be issued any license or driver permit until the person

1 is old enough to be eligible for a license.

2 “(9) In addition to any other application requirements for the special  
3 student driver permit, the applicant must:

4 “(a) Certify that the applicant has no other available means of transpor-  
5 tation that would enable the applicant to continue the applicant’s education;

6 “(b) Specify the road or highway over which the applicant desires to op-  
7 erate motor vehicles;

8 “(c) Obtain the [*endorsement*] **approval** of the sheriff of the county in  
9 which the applicant resides and of the principal of the school the applicant  
10 attends; and

11 “(d) Provide any other information required by the department.

12 “**SECTION 12.** ORS 807.310 is amended to read:

13 “807.310. (1) The Department of Transportation shall provide for the is-  
14 suance of applicant temporary driver permits in a manner consistent with  
15 this section.

16 “(2) The department may issue an applicant temporary driver permit to  
17 an applicant for a **Class C** driver license or for a **noncommercial** driver  
18 permit while the department is determining all facts relative to application  
19 for the **Class C** driver license or **noncommercial** driver permit. The de-  
20 partment shall set forth on the applicant temporary driver permit the driving  
21 privileges granted under the permit.

22 “(3) The holder of an applicant temporary driver permit must have the  
23 temporary driver permit on the holder’s person while operating a motor ve-  
24 hicle. The holder of an applicant temporary driver permit must operate  
25 within the driving privileges granted under the temporary driver permit.

26 “(4) An applicant temporary driver permit is valid for a period of 30 days  
27 from the date issued. The department may extend the term of the permit for  
28 sufficient cause. An extension of the term of the permit may not exceed an  
29 additional 30 days.

30 “(5) An applicant temporary driver permit automatically becomes invalid

1 if the applicant's license or permit is issued or refused for good cause.

2 “(6) The department may not charge a fee for issuance of an applicant  
3 temporary driver permit under this section.

4 “(7) **The department may, by rule, establish when an applicant may**  
5 **be issued a temporary driver permit for commercial driving privileges.**

6 “**SECTION 13.** ORS 809.520, as amended by sections 107 and 108, chapter  
7 630, Oregon Laws 2021, is amended to read:

8 “809.520. (1) Notwithstanding ORS 809.510 **(1) to (5) and (7)**, the Depart-  
9 ment of Transportation shall permanently suspend a person's commercial  
10 driving privileges for the lifetime of the person if the department receives a  
11 record of conviction for a crime punishable as a felony in which a motor  
12 vehicle was used and that involved the manufacturing, distributing or dis-  
13 pensing of a controlled substance, as defined in ORS 475.005. The department  
14 may not reinstate commercial driving privileges of a person whose commer-  
15 cial driving privileges are suspended under this subsection.

16 “(2) Notwithstanding ORS 809.510 **(1) to (5) and (7)**, the department shall  
17 permanently suspend a person's commercial driving privileges for the lifetime  
18 of the person if the department receives a record of conviction for a crime  
19 in which a commercial motor vehicle was used and that involved an act or  
20 practice of severe forms of trafficking in persons as defined by the depart-  
21 ment by rule. The department may not reinstate commercial driving privi-  
22 leges of a person whose commercial driving privileges are suspended under  
23 this subsection.

24 “(3)(a) Notwithstanding ORS 809.510 **(1) to (5) and (7)**, the department  
25 shall suspend a person's commercial driving privileges for the lifetime of the  
26 person if the department receives a second or subsequent record, report or  
27 notice described in ORS 809.510 **(1) to (5) and (7)** that does not arise out  
28 of the same incident and that would be grounds for suspension of the  
29 person's commercial driving privileges under ORS 809.510 **(1) to (5) and**  
30 **(7).**

1 “(b) The department may adopt rules providing for the reinstatement of  
2 commercial driving privileges suspended under this subsection. The depart-  
3 ment may not reinstate commercial driving privilege suspensions under this

13 “(4) A suspension imposed under this section is consecutive to any other  
14 suspension imposed under ORS 809.510, 809.525, 809.530 or 809.535, if the  
15 suspensions do not arise out of the same incident.

16 **“SECTION 14.** ORS 820.110 is amended to read:

17 “820.110. (1) The State Board of Education shall adopt and enforce rules

2 **ent the evidence reviewed by the weighmaster or motor carrier**  
3 **enforcement officer as the basis for issuing a citation listed under ORS**  
4 **810.530.**

5 “[3)(a)] (4)(a) As used in this section, ‘duly authorized traffic enforce-  
6 ment agent’ means an individual who:

7 “(A) Is employed, appointed and duly sworn in by the governing body of  
8 the incorporated city in which the agent performs the agent’s duties; and

9 “(B) Has completed all necessary technical, administrative and other  
10 training to review photographs and issue citations under ORS 810.436,  
11 810.437 or 810.444.

12 “(b) Duly authorized traffic enforcement agents are not police officers as  
13 defined in ORS 801.395.

16

17 **“SECTION 16.** ORS 822.035 is amended to read:

18 “822.035. The Department of Transportation:

19 “(1) Upon receipt of an application for a vehicle dealer certificate, shall  
20 examine the application and may make an individual investigation relative  
21 to statements contained in the application.

22 “(2) Upon being satisfied that an applicant is entitled to a vehicle dealer  
23 certificate and that the proper fees have been paid for the certificate, shall  
24 assign the vehicle dealer a distinctive dealer number that allows the dealer  
25 to conduct business under the certificate and shall forward to the dealer a  
26 vehicle dealer certificate stating thereon the dealer’s number.

27 “(3) Has authority to determine whether or not an applicant for a vehicle  
28 dealer certificate is a vehicle dealer.

29 “(4) Has authority to make suitable rules for the issuance of vehicle  
30 dealer certificates to expire consistently with ORS [822.040] **822.020.**

1 “(5) May make inspections of any vehicle dealer records required under  
2 ORS 822.045 and of any vehicles included in a vehicle dealer’s inventory or  
3 located on the vehicle dealer’s premises. Inspections authorized by this sub-  
4 section may be conducted by the department at reasonable intervals[, *during*  
5 *normal business hours*,] and may not exceed a scope of inspection necessary  
6 for the department to determine the following:

7 “(a) A vehicle dealer’s compliance with statutes regulating vehicle dealers  
8 under the vehicle code;

9 “(b) A vehicle dealer’s compliance with those provisions of the vehicle  
10 code regulating the titling and registration of vehicles;

11 “(c) A vehicle dealer’s compliance with rules adopted by the department  
12 relating to the regulation of vehicle dealers and the registration and titling  
13 of vehicles; and

14 “(d) The identification of stolen vehicles.

15 “**(6) May make inspections during the normal business hours of the**  
16 **department, from Monday through Friday.**

17 “[6] **(7)** Shall provide a vehicle dealer with plates or devices authorized  
18 under ORS 805.200 to allow the exercise of the privileges granted under ORS  
19 822.040.

20 “[7] **(8)** May provide a vehicle dealer with identification cards in the  
21 names of the owners of the business or in the names of authorized employees  
22 of the business.

23 “[8] **(9)** May not issue a vehicle dealer certificate under ORS 822.020 to  
24 an applicant who has been issued a similar certificate from another juris-  
25 diction that has been revoked or is currently suspended unless the applicant  
26 possesses a current, valid vehicle dealer certificate issued under ORS 822.020.

27 “[9] **(10)** May not use the revocation or suspension by another [*state*]  
28 **jurisdiction** of a vehicle dealer certificate or similar certificate as a basis  
29 for refusing to allow a vehicle dealer holding a current, valid vehicle dealer  
30 certificate issued under ORS 822.020 to obtain a vehicle dealer certificate

1 under ORS 822.020 or a supplemental certificate under ORS 822.040 [*or to*  
2 *renew a certificate under ORS 822.040*].

3 “[~~(10)~~] **(11)** May adopt any reasonable rules necessary for the adminis-  
4 tration of the laws relating to the regulation of vehicle dealers, the issuance  
5 of vehicle dealer certificates, the issuance of vehicle dealer identification  
6 cards, regulation of vehicle dealers designated as agents under ORS 802.031  
7 and the issuance of vehicle dealer plates. The rules adopted under this sub-  
8 section must be consistent with the statutory provisions of the vehicle code.  
9 The rules may include, but are not limited to, grounds and procedures for  
10 the revocation, denial, probation or suspension of vehicle dealer certificates  
11 or of a vehicle dealer’s designation to act as an agent of the department.

28 **expires three years after the date of issuance or renewal.**

29 **“(3) A vehicle dealer certificate may be renewed if the applicant for**  
30 **renewal does all of the following:**

1       “(a) Pays the required fee for renewal under ORS 822.700.

2       “(b) Delivers to the department a bond that meets the requirements  
3 under ORS 822.030.

4       “(c) Delivers to the department a certificate of insurance that  
5 meets the requirements under ORS 822.033.

6       “(d) Provides the names of all partners or corporate officers.

7       “(e) Certifies completion of the continuing education requirements  
8 of ORS 822.027 (1)(b) if the person is a dealer subject to the education  
9 requirements.

10       “(f) If the dealer offers new recreational vehicles for sale under the  
11 certificate, certifies that the dealer maintains a recreational vehicle  
12 service facility as listed in the dealer certificate application described  
13 in ORS 822.025.

14       “(4) If a civil penalty assessed under ORS 822.009 remains unpaid  
15 after the date of issuance of the final order, the department may re-  
16 fuse to issue or renew a vehicle dealer certificate under this section,  
17 until the civil penalty is paid in full or until six years have passed  
18 since the date of issuance of the final order, whichever occurs first.

19       “(5) The department may adopt rules for the issuance and renewal  
20 of vehicle dealer certificates under this section.

21       “SECTION 18. ORS 822.040 is amended to read:

22       “822.040. (1) The holder of a current, valid vehicle dealer certificate issued  
23 under ORS 822.020 may exercise the following privileges under the certif-  
24 icate:

25       “(a) **Subject to ORS 822.045**, a dealer is authorized, without violating  
26 ORS 803.025 or 803.300, to use and operate over and along the highways of  
27 this state [all] vehicles displaying the dealer’s plates whether registered or  
28 not or whether or not a title is issued for the vehicle[.] **if the vehicle:**

29       “(A) **Is owned or controlled by the dealer;**

30       “(B) **Is used by the dealer, members of the dealer’s firm, any**

1 **salesperson thereof or any person authorized by the dealer;**

2 **“(C) Indicates it is offered for sale; and**

3 **“(D) When offered for sale, is available for display during the vehi-**  
4 **cle dealer’s normal business hours.** *[This paragraph does not authorize*  
5 *dealers to use or operate vehicles under dealer plates unless the vehicles are*  
6 *actually owned or controlled by the dealer and in actual use by the dealer,*  
7 *members of the dealer’s firm, any salesperson thereof or any person authorized*  
8 *by the dealer. Vehicles operated under dealer plates may be used for the same*  
9 *purposes as are any other vehicles registered in this state that are registered*  
10 *by payment of the fee under ORS 803.420. This paragraph is subject to the*  
11 *limitations under ORS 822.045.]*

12 **“(b) A dealer is entitled to receive dealer plates or devices and replace-**  
13 **ment or additional dealer plates or devices. As many additional dealer plates**  
14 **as may be desired may be obtained upon the filing of a formal application**  
15 **for additional plates with the Department of Transportation. The plates is-**  
16 **sued to dealers shall require the payment of fees as provided under ORS**  
17 **805.250.**

18 **“(c) The person is not subject to the prohibitions and penalties under ORS**  
19 **822.005 as long as the holder’s vehicle dealer business is conducted in a lo-**  
20 **cation approved under the certificate.**

21 **“(d) The dealer shall be considered the owner of vehicles manufactured**  
22 **or dealt in by the dealer, before delivery and sale of the vehicles, and of all**  
23 **vehicles in the dealer’s possession and operated or driven by the dealer or**  
24 **the dealer’s employees.**

25 **“(e) Notwithstanding ORS 825.474, in lieu of paying the weight-mile tax**  
26 **imposed under ORS 825.474, the dealer may pay the fuel taxes imposed under**  
27 **ORS 319.020 and 319.530, when the vehicle:**

28 **“(A) Displays the dealer’s plates;**

29 **“(B) Is actually owned or controlled by the dealer and in actual use by**  
30 **the dealer, members of the dealer’s firm, any salesperson of the dealer or any**

1 person authorized by the dealer;

2 “(C) Is operated on the highway for the purpose of test driving the vehi-  
3 cle; and

4 “(D) Is unloaded.

5 “(2) The holder of a vehicle dealer certificate may open additional places  
6 of business under the same business name by obtaining a supplemental cer-  
7 tificate from the department under this subsection. The following all apply  
8 to a supplemental certificate issued under this subsection:

9 “(a) The department may not issue a supplemental certificate under this  
10 subsection if the additional place of business opened will be operated under  
11 a different business name than that indicated on the current certificate. Any  
12 business that a vehicle dealer operates under a separate business name must  
13 be operated under a separate certificate and the dealer must apply for and  
14 pay the fees for a regular dealer certificate for the business.

15 “(b) A supplemental certificate issued under this subsection is subject to  
16 the fee for supplemental certificate under ORS 822.700.

17 “(3) The holder of a vehicle dealer certificate may move a place of busi-  
18 ness or change a business name by obtaining a corrected certificate from the  
19 department. For purposes of this subsection, ‘place of business’ includes a  
20 recreational vehicle service facility as defined in ORS 822.082. The following  
21 apply to a corrected certificate issued under this subsection:

22 “(a) The department shall prescribe the form for application for a cor-  
23 rected certificate.

24 “(b) A person applying for a corrected certificate shall pay the fee for the  
25 corrected certificate established in ORS 822.700.

26 “(4) The department may establish by rule the requirements a holder of  
27 a vehicle dealer certificate must meet to display a vehicle at a location other  
28 than the dealer’s place of business for the purpose of advertising without  
29 first obtaining a supplemental certificate from the department. In addition  
30 to any requirements established by the department by rule, all of the fol-

1    lowing apply:

2       “(a) The dealer must have a signed agreement with the owner of the  
3   property or the person using the property where the vehicle is to be dis-  
4   played stating that the vehicle is for an advertising promotion only and that  
5   the processing of any documents or other activities required to purchase a  
6   vehicle must be done at the dealer’s place of business.

7       “(b) The vehicle on display must be clearly marked with the dealer’s name  
8   and contact information and a notice that the vehicle is displayed only for  
9   the purpose of advertising and may be purchased only at the dealer’s place  
10  of business.

11      “(c) Displaying the vehicle must not violate any zoning laws or ordi-  
12  nances.

13      “(d) The dealer or the dealer’s employees may not remain with the vehicle  
14  except for the purpose of moving the vehicle in or out of the display area.

15      “[(5) *A vehicle dealer certificate is valid for a three-year period and may*  
16  *be renewed as provided by the department. The department shall only renew*  
17  *a certificate if the applicant for renewal does all of the following:]*

18          “[(a) *Pays the required fee for renewal under ORS 822.700.]*

19          “[(b) *Delivers to the department a bond that meets the requirements under*  
20  *ORS 822.030.]*

21          “[(c) *Delivers to the department a certificate of insurance that meets the*  
22  *requirements under ORS 822.033.]*

23          “[(d) *Provides the names of all partners or corporate officers.]*

24          “[(e) *Certifies completion of the continuing education requirements of ORS*  
25  *822.027 (1)(b) if the person is a dealer subject to the education requirements.]*

26          “[(f) *If the dealer offers new recreational vehicles for sale under the certif-*  
27  *icate, certifies that the dealer maintains a recreational vehicle service facility*  
28  *as listed in the dealer certificate application described in ORS 822.025.]*

29      “[(6) *The department may adopt suitable rules for the issuance and renewal*  
30  *of certificates under this section and ORS 822.020.]*



1       **“SECTION 19.** ORS 822.050 is amended to read:

2       “822.050. (1) The Department of Transportation may revoke, suspend or  
3 place on probation a vehicle dealer if the department determines at any time  
4 for due cause that the dealer has done any of the following:

5       “(a) Violated any grounds for revocation, suspension or probation adopted  
6 by the department by rule under ORS 822.035.

7       “(b) Failed to comply with the requirements of the vehicle code with ref-  
8 erence to notices or reports of the transfer of vehicles or campers.

9       “(c) Caused or suffered or is permitting the unlawful use of any certificate  
10 or registration plates.

11       “(d) Violated or caused or permitted to be violated ORS 815.410, 815.415,  
12 815.425 or 815.430.

13       “(e) Falsely certified under ORS 822.033 that the dealer is exempt from  
14 the requirement under ORS 822.020 [*or 822.040*] to file a certificate of insur-  
15 ance.

16       “(f) Continued to fail to provide clear title or repeatedly failed to provide  
17 clear title in violation of ORS 822.045.

18       “(g) Knowingly certified false information required by the department on  
19 an application for a vehicle dealer certificate, supplemental certificate or  
20 corrected certificate.

21       **“(h) Failed to pay a civil penalty assessed under ORS 822.009 and the**  
22 **amount of penalty was not paid within 10 days after the order becomes**  
23 **final.**

24       **“(i) Displayed dealer plates on vehicles unless the vehicle was of-**  
25 **fered for sale.**

26       “(2) The department shall cancel a vehicle dealer certificate 45 days after  
27 receipt of legal notice that the bond described under ORS 822.030 is canceled,  
28 unless the department receives proof from the vehicle dealer that the dealer  
29 has obtained another bond. Between the day that the department receives  
30 notice that the bond is canceled and the day the vehicle dealer presents proof

1 of another bond, the vehicle dealer may not act as a vehicle dealer.

2 “(3) The department shall cancel a vehicle dealer certificate 45 days after  
3 receipt of notice that the certificate of insurance required under ORS 822.033  
4 is canceled, unless the department receives proof from the vehicle dealer that  
5 the dealer has obtained another certificate of insurance. Between the day  
6 that the department receives notice that the certificate of insurance is can-  
7 celed and the day the vehicle dealer presents proof of another certificate of  
8 insurance, the vehicle dealer may not act as a vehicle dealer.

9 “(4) The department shall cancel a vehicle dealer certificate immediately  
10 upon receipt of notice that zoning approval for the business has been re-  
11 voked.

12 “(5) Upon revocation, cancellation or suspension of a vehicle dealer cer-  
13 tificate under this section, the department shall recall and demand the return  
14 of the certificate and any vehicle dealer plates issued.

## 16 “VEHICLE REGISTRATION PLATES

17

18 “**SECTION 20.** ORS 805.210 is amended to read:

19 “805.210. (1) The owner of a vehicle of special interest may apply to the  
20 Department of Transportation for permission to use special interest regis-  
21 tration plates. To receive permission to use special interest registration  
22 plates the person must:

23 “(a) Maintain the vehicle of special interest as a collectors’ item and use  
24 the vehicle only for exhibitions, parades, club activities and similar uses but  
25 not use the vehicle primarily for the transportation of persons or property;

26 “(b) Supply the special interest registration plates which the person de-  
27 sires to use; and

28 “(c) Include the plates with the application for permission to use them.

29 “(2) **The department shall determine which special interest plates**  
30 **are available for issuance under this section.**

1        “[2] (3) The department, prior to approval of an application under this  
2 section, shall determine that the special interest registration plates meet the  
3 following requirements:

4        “(a) The plates shall be issued by the State of Oregon for use on vehicles  
5 in this state.

6        “(b) The numbers and characters on the plate shall be distinctive.

7        “(c) The plates shall be legible, durable and otherwise of a size, shape,  
8 color and design that will serve the purposes of safety and identification.

9        “(d) If the plates are from a series of plates in current use, the plates  
10 shall be from the same year or period of issue in which the vehicle was  
11 manufactured.

12       “[3] (4) If the special interest registration plate offered for approval was  
13 issued in a year in which single registration plates only were required, the  
14 department shall grant permission for use of that registration plate alone if  
15 it is otherwise acceptable.

16       “[4] (5) If the special interest registration plates offered for approval are  
17 from a series of plates in current use, as described in subsection [(2)(d)]  
18 (3)(d) of this section, the department may affix a distinctive sticker to each  
19 plate at the time of approval. Stickers shall be of a size, color and design  
20 determined by the department and shall be displayed on plates in the manner  
21 determined by the department.

22       “[5] (6) The department may approve plates issued by the state that have  
23 been restored to their original color and design provided that if the plate  
24 was reflectorized when originally issued, it must be fully reflectorized when  
25 restored.

26       **“SECTION 21.** ORS 803.530 is amended to read:

27       “803.530. (1) Registration plates assigned to a vehicle by the Department  
28 of Transportation shall remain with the vehicle to which the plates are as-  
29 signed and are valid only during the registration period for which the plates  
30 are issued except as provided in this section.

1 “(2) The department may allow registration plates to be transferred to  
2 another vehicle if:

3 “(a) The department receives an application;

4 “(b) The applicant pays the plate transfer fee under ORS 803.575; and

5 “(c) The applicant complies with the registration qualifications described  
6 in ORS 803.350.

7 “(3) The department shall transfer registration plates under this section  
8 if the applicant and the vehicle qualify for the plates and the plates are:

9 “(a) Legible and capable of being used for identification purposes; and

10 “(b) Any of the following:

11 “(A) From a current issue of registration plates;

12 “(B) Customized registration plates described under ORS 805.240;

13 “(C) Oregon Trail commemorative registration plates issued under section  
14 113, chapter 741, Oregon Laws 1993;

15 “(D) Special registration plates issued under ORS 805.255, 805.260, 805.263,  
16 805.266, 805.278 or 805.283;

17 “(E) Group registration plates issued under ORS 805.205;

18 “(F) Veterans’ recognition registration plates issued under ORS 805.105;

19 “(G) Pacific Wonderland registration plates issued under ORS 805.287; or

20 “(H) Registration plates issued through the special registration program  
21 under ORS 805.222.

22 “(I) **Registration plates that are no longer currently issued that the**  
23 **department determines may still be transferred.**

24 “(4) Notwithstanding ORS 803.400, when registration plates are trans-  
25 ferred from one vehicle to another vehicle owned by the same person, the  
26 registration period represented by the plates also transfers with the plates.  
27 When registration plates are transferred from one vehicle to another vehicle  
28 not owned by the same person, the remaining registration period represented  
29 by the transferred plates ceases for both the vehicle receiving the transferred  
30 plates and the vehicle from which the plates were removed.

1       “(5) The owner of a registered vehicle to which a plate is assigned may  
2 replace a registration plate. The following apply to this subsection:

3       “(a) To replace a plate under this subsection, the owner must apply to the  
4 department for replacement of the plate in a form prescribed by the depart-  
5 ment and pay the replacement plate fee established under ORS 803.575.

6       “(b) The department, in lieu of replacement, may issue duplicate plates for  
7 the same fee as charged for replacements.

8       “(c) The plates issued under this subsection are valid only for the period  
9 of the plates replaced.

10       “(d) The replaced plates may not be considered customized plates when  
11 they are replaced, if:

12       “(A) The original plates were from plates currently issued;

13       “(B) The original plates were not customized plates; and

14       “(C) The replacement plates are a duplicate of the original plates.

15       “(e) When a vehicle is assigned a pair of plates and the owner wishes to  
16 replace a single plate, the department may replace a single plate rather than  
17 replace both plates.

18       “(6) A county may replace a registration plate that is from a specially  
19 designed government series with a registration plate that is from a regular  
20 series. The following apply to this subsection:

21       “(a) To replace a plate under this subsection, the county must apply to  
22 the department for replacement of the plate in a form prescribed by the de-  
23 partment and pay the replacement plate fee established under ORS 803.575.

24       “(b) The plates issued under this subsection are valid only for the period  
25 of the plates replaced.

26       “(7) If the department retired the vehicle’s registration under ORS 819.030  
27 because the vehicle is totaled or substantially altered, a person may apply  
28 under subsection (2) of this section to transfer the registration plates to an-  
29 other vehicle.

30       “(8) Subject to subsections (2) and (4) of this section, after the department

1 authorizes the use of special interest plates under ORS 805.210, a person may  
2 apply to transfer the plates to either:

3 “(a) A vehicle that was previously determined by the department to  
4 qualify as a vehicle of special interest; or

5 “(b) A vehicle approved by the department as a vehicle of special interest  
6 at the time of application.

7 “(9) If a person described in subsection (8) of this section provides the  
8 department with only one special interest registration plate for transfer and  
9 the department’s vehicle records show the special interest registration plate  
10 belongs to a vehicle record with no owner matching an applicant, the appli-

5 interest in a motor vehicle, an odometer disclosure statement shall be made

9 “(3) If a transfer requiring a disclosure statement involves a leased vehi-  
10 cle, the lessor shall notify the lessee that the lessee is required to provide

4 “(3) A [*person*] **qualified provider** authorized to transact business for the  
5 department under this section, including but not limited to a [*person*] **qual-  
6 ified provider** who transacts business under contract with an integrator,  
7 may charge a fee for the services provided. Fees authorized under this sub-  
8 section are in addition to any charges or fees that the department is au-  
9 thorized by statute to collect for the transaction.

10 “(4)(a) The department may adopt such rules as are necessary to carry out  
11 the provisions of this section, including but not limited to rules that:

12 “(A) Specify criteria for eligibility of a [*person*] **qualified provider** to  
13 enter into an agreement with the department under this section.

12 **ON HIGHWAY RIGHT OF WAY**

15 **an intergovernmental agreement with a city that has a population of**  
16 **500,000 or more for the removal, storage and disposition of personal**  
17 **property deposited, left or displayed on property that is owned by the**

30 another certificate issued under ORS 822.020 [*or 822.040*].

1 “(3) The continuing education requirements of subsection (1)(b) of this  
2 section do not apply to an applicant for renewal of a vehicle dealer certifi-  
3 cate under ORS [822.040] **822.020** if the applicant is:

4 “(a) A dealer having a franchise in this state for nationally advertised  
5 and recognized motor vehicles;

6 “(b) A dealer having a franchise in this state for new recreational vehi-  
7 cles;

8 “(c) A motor vehicle rental company having a national franchise under  
9 the ownership of a corporation that operates throughout the United States;

10 or

11 “(d) A national auction company that holds a vehicle dealer certificate  
12 and a dismantler certificate whose primary activity in this state is the sale  
13 or disposition of totaled vehicles.

14 “(4) Precertification and continuing education programs and the tests re-  
15 quired in subsection (1) of this section may be developed by any motor ve-  
16 hicle industry organization including, but not limited to, the Oregon  
17 Independent Auto Dealers Association. Each education program shall be  
18 submitted to the advisory committee established under ORS 802.370 for ap-  
19 proval every two years. The committee shall vote to approve or deny ap-  
20 proval of each program. A program that is approved must cover state and  
21 federal law in at least the following areas:

22 “(a) Motor vehicle advertising;

23 “(b) Odometer laws and regulations;

24 “(c) Vehicle licensing and registration;

25 “(d) Unlawful dealer activities;

26 “(e) Environmental rules and regulations;

27 “(f) Oregon and industry standard motor vehicle forms;

28 “(g) Truthful lending practices;

29 “(h) Motor vehicle financing;

30 “(i) Service and warranty contracts; and

1 “(j) Land use regulations governing motor vehicle dealers.

2 “(5) Precertification and continuing education programs required in sub-  
3 section (1) of this section may be provided by accredited educational insti-  
4 tutions, private vocational schools, correspondence schools or trade  
5 associations if the education programs have been approved by the advisory  
6 committee established under ORS 802.370 as required in subsection (4) of this  
7 section.

8 “(6) The approval of an education program under subsection (4) of this  
9 section expires two years from the date of the approval.

10 **“SECTION 45.** ORS 822.030 is amended to read:

11 “822.030. (1) A bond or letter of credit required to qualify for a vehicle  
12 dealer certificate under ORS 822.020 [*or to qualify for renewal of a certificate*  
13 *under ORS 822.040*] must comply with all of the following:

14 “(a) The bond shall have a corporate surety licensed to do business within  
15 this state. A letter of credit shall be an irrevocable letter of credit issued  
16 by an insured institution, as defined in ORS 706.008. The surety or institu-  
17 tion shall notify the Department of Transportation if the bond or letter of  
18 credit is canceled for any reason. The surety or institution shall continue to  
19 be liable under the bond or letter of credit until the department receives the  
20 notice required by this paragraph, or until the cancellation date specified in  
21 the notice, whichever is later.

22 “(b) The bond or letter of credit shall be executed to the State of Oregon.

23 “(c) Except as otherwise provided in this paragraph, the bond or letter  
24 of credit shall be in the following sum:

25 “(A) If the person holds a certificate to be a dealer exclusively in motor-  
26 cycles, mopeds, Class I all-terrain vehicles or snowmobiles or any combina-  
27 tion of those vehicles, the bond or letter of credit shall be for \$10,000.

28 “(B) Except as provided in subparagraph (A) of this paragraph, if the ap-  
29 plicant is seeking a certificate to be a vehicle dealer, the bond or letter of  
30 credit shall be for \$50,000 for each year the certificate is valid.

1       “(d) The bond or letter of credit described in this subsection shall be ap-  
2 proved as to form by the Attorney General.

3       “(e) The bond or letter of credit must be conditioned that the person is-  
4 sued the certificate shall conduct business as a vehicle dealer without fraud  
5 or fraudulent representation and without violating any provisions of the ve-  
6 hicle code relating to vehicle registration, vehicle permits, the transfer or  
7 alteration of vehicles or the regulation of vehicle dealers.

8       “(f) The bond or letter of credit must be filed and held in the office of the  
9 department.

10       “(g) The vehicle dealer shall purchase a bond or letter of credit under this  
11 subsection annually on or before each anniversary of the issuance of the  
12 vehicle dealer’s certificate.

13       “(2) Any person shall have a right of action against a vehicle dealer,  
14 against the surety on the vehicle dealer’s bond and against the letter of  
15 credit in the person’s own name if the person suffers any loss or damage by  
16 reason of the vehicle dealer’s fraud, fraudulent representations or violations  
17 of provisions of the vehicle code relating to:

18       “(a) Vehicle registration;

19       “(b) Vehicle permits;

20       “(c) The transfer or alteration of vehicles; or

21       “(d) The regulation of vehicle dealers.

22       “(3) Notwithstanding subsection (2) of this section, the maximum amount  
23 available under a bond or letter of credit described in subsection (1)(c)(B)  
24 of this section for the payment of claims to persons other than retail cus-  
25 tomers of the dealer is \$10,000.

26       “(4) Notwithstanding subsection (2) of this section, a person other than  
27 a retail customer of the vehicle dealer may not make a claim under sub-  
28 section (2) of this section against the surety on the vehicle dealer’s bond, or  
29 against the vehicle dealer’s letter of credit, if the vehicle dealer holds a ve-  
30 hicle dealer certificate to deal exclusively in motorcycles, mopeds, Class I

1 all-terrain vehicles or snowmobiles or any combination of those vehicles.

2 “(5) If the certificate of a vehicle dealer is not renewed or is voluntarily  
3 or involuntarily canceled, the sureties on the bond and the issuer of the  
4 letter of credit are relieved from liability that accrues after the department  
5 cancels the certificate.

6 **“SECTION 46.** ORS 822.033 is amended to read:

7 “822.033. A certificate of insurance required to qualify for a vehicle dealer  
8 certificate under ORS 822.020 or to qualify for renewal of a certificate under  
9 ORS [822.040] **822.020** must comply with all of the following:

10 “(1) The certificate shall:

11 “(a) Be issued by an insurance carrier licensed to do business within this  
12 state;

13 “(b) Show that the dealer is insured by a policy that provides the mini-  
14 mum limits of coverage required under ORS 806.070;

15 “(c) Show that the dealer is insured by a policy that provides for payment  
16 of judgments of the type described in ORS 806.040;

17 “(d) Show that the dealer is insured by a policy covering all vehicles  
18 manufactured, owned, operated, used or maintained by or under the control  
19 of the dealer;

20 “(e) Show that the dealer is insured by a policy that also covers all other  
21 persons who, with the consent of the dealer, use or operate vehicles manu-  
22 factured, owned or maintained by or under the control of the dealer;

23 “(f) Be dated as of the date of the motor vehicle policy for which it is  
24 given;

25 “(g) Contain the policy number; and

26 “(h) Provide that the insurer shall give the Department of Transportation  
27 written notice of any cancellation of the policy and that the insurer shall  
28 continue to be liable under the policy until the department receives the no-  
29 tice required by this paragraph or until the cancellation date specified in the  
30 notice, whichever is later.

1 “(2) The certificate of insurance must be filed and held in the office of  
2 the department.

3 “(3) A dealer is exempt from the requirement to file the certificate of in-  
4 surance described in this section if the dealer certifies, in such form as may  
5 be required by the department, that the dealer will be dealing exclusively in  
6 one or more of the following:

7 “(a) Antique vehicles issued permanent registration under ORS 805.010;

8 “(b) Farm trailers;

9 “(c) Farm tractors;

10 “(d) Implements of husbandry; or

11 “(e) Snowmobiles, Class I or Class III all-terrain vehicles.

12 **“SECTION 47.** ORS 822.045 is amended to read:

13 “822.045. (1) A vehicle dealer improperly conducts a vehicle dealer busi-  
14 ness and is subject to the penalties under this section if the vehicle dealer  
15 commits any of the following offenses:

16 “(a) A vehicle dealer commits the offense of failure to obtain a supple-  
17 mental vehicle dealer certificate if the vehicle dealer opens any additional  
18 place of business using the same business name as a place of business ap-  
19 proved under a vehicle dealer certificate without first obtaining a supple-  
20 mental dealer certificate under ORS 822.040.

21 “(b) A vehicle dealer commits the offense of failure to obtain a corrected  
22 vehicle dealer certificate if the dealer moves a place of business or changes  
23 the business name without first obtaining a corrected dealer certificate under  
24 ORS 822.040.

25 “(c) A vehicle dealer commits the offense of failure to maintain proper  
26 vehicle dealer records if the dealer does not keep records or books with all  
27 of the following information concerning any used or secondhand vehicles or

30 for purpose of sale.

1       “(B) A description of the vehicle or camper.

2       “(C) The name and address of the seller, the purchaser and the alleged  
3 owner or other person from whom the vehicle or camper was purchased or  
4 received or to whom it was sold or delivered.

5       “(D) For motor vehicles, the vehicle identification number and any other  
6 numbers or identification marks as may be thereon and a statement that a  
7 number has been obliterated, defaced or changed, if such is a fact.

8       “(E) For trailers and campers, the vehicle identification number and any  
9 other numbers or identification marks as may be thereon.

10       “(F) A duly assigned certificate of title or other primary ownership record  
11 or a bill of sale from the registered owner of the vehicle or camper from the  
12 time of delivery to the dealer until the dealer disposes of the vehicle or  
13 camper. If title is issued for the vehicle in a form other than a certificate,  
14 or if the primary ownership record is in a form other than a document, a  
15 dealer shall keep records in accordance with rules adopted by the Depart-  
16 ment of Transportation for the purpose of complying with this subparagraph.

17       “(d) A vehicle dealer commits the offense of failure to allow administra-  
18 tive inspection if the dealer refuses to allow the department to conduct an  
19 inspection under ORS 822.035 at any time during normal business hours.

20       “(e) A vehicle dealer commits the offense of failure to allow police in-  
21 spection if the dealer refuses to allow any police officer to conduct an in-  
22 spection under ORS 810.480 at any time during normal business hours.

23       “(f) A vehicle dealer commits the offense of illegal use of dealer vehicle  
24 for hire if the dealer allows any vehicle operated under vehicle dealer reg-  
25 istration to be loaned or rented with or without driver for hire or direct  
26 compensation.

27       “(g) A vehicle dealer commits the offense of improper use of dealer plates  
28 or devices if the dealer or employee of the dealer causes or permits the dis-  
29 play or use of any special vehicle dealer registration plate or device on any  
30 vehicle not owned or controlled by the dealer.



1       “(h) A person commits the offense of improper display of dealer plates if  
2 the person operates over and along the highways of this state any unregis-  
3 tered vehicle owned or controlled by the dealer and any dealer plates issued  
4 are not displayed in the manner provided in ORS 803.540 for the display of  
5 registration plates.

6       “(i) A vehicle dealer commits the offense of failure to exhibit the dealer  
7 certificate if the dealer fails to permanently exhibit the certificate at the  
8 place of business of the person at all times while the certificate is in force.

9       “(j) Except as provided in subsection (2) of this section, a vehicle dealer  
10 commits the offense of failure to provide clear title if:

11       “(A) Within 15 days of transfer of any interest in a vehicle or camper to  
12 the dealer by a consumer, the dealer fails to satisfy:

13       “(i) The interest of any person from whom the dealer purchased or ob-  
14 tained the vehicle or camper;

15       “(ii) The interest of any person from whom the person described in sub-  
16 subparagraph (i) of this subparagraph leased the vehicle or camper; and

17       “(iii) All security interests in the vehicle or camper entered into prior to  
18 the time of transfer.

19       “(B) Within 15 days of receiving clear title to a vehicle or camper from  
20 another dealer, the purchasing dealer fails to satisfy the interest of the  
21 dealer from which the purchasing dealer received the certificate of title or  
22 other primary ownership document. For purposes of this subparagraph, a  
23 purchasing dealer receives a certificate of title or other primary ownership  
24 document from a dealer on the date:

25       “(i) The purchasing dealer or the Department of Transportation takes  
26 physical possession of the certificate or document; or

27       “(ii) A written notice is mailed by certified or registered mail, return re-  
28 ceipt requested, to the purchasing dealer from the dealer, stating that the  
29 certificate or document is available to be picked up at a place and time  
30 prearranged by both parties. The written notice must be mailed to a business

1 address of the purchasing dealer that is on file with the department. Service  
2 by mail under this sub-subparagraph is effective on the date of mailing.

3 “(k) Except as provided in subsection (3) of this section, a vehicle dealer  
4 commits the offense of failure to furnish certificate of title or application for  
5 title if, within 90 calendar days of transfer of any interest in a vehicle or  
6 camper by the dealer, the dealer has failed to:

7 “(A) Furnish the certificate of title or other primary ownership record for  
8 the vehicle or camper and any release thereon or, if title has been issued or  
9 is to be issued in a form other than a certificate, any information or docu-  
10 ments required by rule of the department, to the security interest holder next  
11 named, if any, otherwise to the lessor or, if none, to the purchaser; or

12 “(B) Submit to the department in a manner that complies with any ap-  
13 plicable statutes and rules, an application for title on behalf of the person  
14 to whom the title is to be furnished or whose name is to be shown on the  
15 title record.

16 “(L) A vehicle dealer commits the offense of failure to maintain bond or  
17 letter of credit coverage if the dealer permits a bond or letter of credit to  
18 lapse during the period that the bond or letter of credit is required under  
19 ORS 822.020 [*or 822.040*] or if the dealer fails to purchase a bond or letter  
20 of credit required by ORS 822.030.

21 “(m) A person commits the offense of acting as a vehicle dealer while  
22 under revocation, cancellation or suspension if the person conducts business  
23 as a vehicle dealer in this state and the person’s vehicle dealer certificate  
24 is revoked, canceled or suspended, regardless of whether the person is li-  
25 censed as a vehicle dealer in another jurisdiction. This paragraph does not  
26 apply if the person has other current, valid dealer certificates issued in this  
27 state.

28 “(n) A vehicle dealer commits the offense of improper display of a vehicle  
29 for advertising purposes if the dealer displays a vehicle at a location other  
30 than the dealer’s place of business for the purpose of advertising and the

1 dealer does not comply with the provisions of ORS 822.040 (4).

2 “(2) A dealer is not considered to have committed the offense described  
3 in subsection (1)(j)(A) of this section if the dealer fails to satisfy an interest  
4 in a vehicle or camper that arises from an inventory financing security in-  
5 terest for which the dealer is the debtor.

6 “(3) A dealer is not considered to have committed the offense described  
7 in subsection (1)(k) of this section if the dealer demonstrates that:

8 “(a) The dealer has made a good faith effort to comply; and

25 “(g) The offense described in this section, improper use of dealer plates  
26 or devices, is a Class D traffic violation.

27 “(h) The offense described in this section, improper display of dealer  
28 plates, is a Class B traffic violation.

29 “(i) The offense described in this section, failure to exhibit the dealer  
30 certificate, is a Class A misdemeanor.

1 “(j) The offense described in this section, failure to provide clear title, is  
2 a Class A misdemeanor.

3 “(k) The offense described in this section, failure to furnish certificate of  
4 title or application for title, is a Class A misdemeanor.

5 “(L) The offense described in this section, failure to maintain bond or  
6 letter of credit coverage, is a Class A misdemeanor.

7 “(m) The offense described in this section, acting as a vehicle dealer while  
8 under revocation, cancellation or suspension, is a Class A misdemeanor.

9 “(n) The offense described in this section, improper display of a vehicle  
10 for advertising purposes, is a Class A misdemeanor.

11 **“SECTION 48.** ORS 822.060 is amended to read:

12 “822.060. (1) Except as provided in subsection (2) of this section, a person  
13 who holds a vehicle dealer certificate issued [*or renewed*] under ORS 822.020  
14 [*or 822.040*] commits the offense of illegal consignment practices if the person  
15 does any of the following:

16 “(a) Takes a vehicle on consignment from a person who does not hold a  
17 vehicle dealer certificate issued [*or renewed*] under ORS 822.020 [*or 822.040*],  
18 or who is not licensed as a vehicle dealer in another jurisdiction, and who  
19 does not have proof that the consignor is the registered owner, a security  
20 interest holder or lessor of the vehicle.

21 “(b) Takes a vehicle on consignment from a security interest holder  
22 without the security interest holder first completing a repossession action  
23 prior to consigning the vehicle and providing the dealer with proper docu-

12 “(g) Takes any part of any money paid to the dealer in connection with  
13 any consignment transaction as part or all of the dealer’s commission or fee  
14 until the transaction has been completed or terminated.

15 “(h) Does not make arrangement for the disposition of money from a  
16 consignment transaction with the seller at the time of establishing a  
17 consignment agreement.

18 “(i) Sells a vehicle that the dealer has taken on consignment without first  
19 giving the purchaser the following disclosure in writing:

6 “(2) The offense described in this section does not apply if the person  
7 takes a vehicle on consignment from an entity other than a retail customer  
8 and the person holds a vehicle dealer certificate issued [*or renewed*] under  
9 ORS 822.020 [*or 822.040*] and operates a:

10 “(a) Wholesale vehicle auction company; or

11 “(b) National auction company whose primary activity in this state is the  
12 sale or disposition of totaled vehicles.

13 “(3) The offense described in this section, illegal consignment practices,  
14 is a Class A misdemeanor.

15 “(4) The department shall adopt rules to carry out the provisions of this  
16 section, including but not limited to rules to specify which persons may take  
17 and sell vehicles on consignment and to regulate the taking and selling of  
18 vehicles on consignment from other jurisdictions.

27 **plates issued before the effective date of this 2023 Act shall continue**  
28 **to be governed by ORS 805.117 as in effect immediately before the ef-**  
29 **fective date of this 2023 Act.**
