1	On page 1 of the printed bill, delete lines 4 through 31 and delete page
2	$\underline{2}$.
3	On page 3, delete lines 1 through 4 and insert:
4	"SECTION 1. ORS 568.560 is amended to read:
5	"568.560. (1) The local governing body of the soil and water conservation
6	district shall consist of a board of either five or seven directors elected or
7	appointed as provided by law. To ensure proper representation of all the
8	people in the district and to facilitate district functions, the State Depart-
9	ment of Agriculture shall provide for the zoning of each district, and shall
10	provide each time directors are elected or appointed for the proper and eq-
11	uitable representation for each zone.
12	"(2) Two director positions shall be at-large positions. At-large directors
13	must reside within the district and be registered voters.
14	"(3)(a) All zone directors must be registered voters and reside within
15	the zones they represent in the district.
16	"(b) In addition to the requirements described in paragraph (a) of

this subsection, zone directors in a district that does not include any

"(A) Own or manage 10 or more acres of land in the zones they repre-

sent in the district[,] and be involved in the active management of the land

[property, reside within the boundaries of the district and be registered voters.

county with a population of 250,000 or more must:

- 1 Zone directors may either reside within the zone that is represented or own
- 2 or manage 10 or more acres within the zone that is represented and be involved
- 3 in the active management of the property. An individual may also serve as a
- 4 zone director when the individual, in lieu of the other requirements specified
- 5 in this subsection, resides within the zone that is represented and indicates];
- 6 **or**
- 7 "(B) Indicate an interest in natural resource conservation as demon-
- 8 strated by serving at least one year as a director or associate director of a
- 9 district and having a conservation plan that is approved by the district.
- "(4) Candidates nominated for director from a specific zone shall be voted
- on by all electors within the district.
- "[(4)] (5) The directors shall designate a chairperson, secretary and other
- officers as necessary and may, from time to time, change such designation.
- "[(5)] (6) The term of office of each director shall be four years, except
- 15 that:
- "(a) Of the directors first appointed under ORS 568.400, two shall serve
- 17 until January first following the first general election following their ap-
- 18 pointment, and three shall serve until January first following the second
- 19 general election following their appointment, as determined by the depart-
- 20 ment, and thereafter, their successors shall be elected as provided by law for
- 21 other elected directors.
- 22 "(b) Of the directors first elected as provided in ORS 568.545 (1), three
- 23 shall serve until January first following the first general election and four
- shall serve until January first following the second general election after the
- date of their election, as determined by them by lot at the meeting referred
- 26 to in ORS 568.545 (1).
- 27 "(c) Of the directors first elected as provided in ORS 568.565 (1), three
- 28 shall serve until January first following the first general election and two
- 29 shall serve until January first following the second general election after the
- 30 date of their election, as determined by them by lot at the meeting referred

- 1 to in ORS 568.565 (1).
- 2 "(d) Of the zone directors elected as provided under ORS 568.565 (2), three
- 3 shall serve until January first following the first general election and two
- 4 shall serve until January first following the second general election after the
- 5 date of their election, as determined by lot at the meeting referred to in ORS
- 6 568.565 (2).
- 7 "[(6)] (7) A director shall hold office until a successor has been elected
- 8 or appointed, has qualified and has taken the oath of office or until the office
- 9 becomes vacant under subsection [(7)] (8) of this section. Any vacancy oc-
- 10 curring in the office of director shall be filled as provided by subsection
- 11 [(8)] **(9)** of this section.
- "[(7)] (8) A director position becomes vacant under the following circum-
- 13 stances:
- "(a) The department, upon the written recommendation of a majority of
- 15 the members of the local governing body of a district, may declare vacant
- 16 the position of a director who is absent from three consecutive meetings of
- 17 the local governing body of the district. A position becomes vacant under
- 18 this paragraph upon the issuance of the declaration by the department.
- "(b) No nominee for the position qualifies under ORS 568.530 to have the
- 20 name of the nominee furnished to the county clerk for placement on the
- general district election ballot and no person qualifies under ORS 568.530 to
- 22 have write-in votes counted. A position becomes vacant under this paragraph
- on January 1.
- "(c) The department determines that a candidate receiving the most votes
- 25 at an election does not qualify under this section to hold the position. A
- 26 position becomes vacant under this paragraph on January 1 next following
- 27 the election at which the unqualified candidate was elected unless an ap-
- pointee to the position has been selected under subsection [(8)] (9) of this
- 29 section.

"(d) A director serving in a position no longer qualifies under this section

- 1 to hold the position. A position becomes vacant under this paragraph upon
- 2 the department's declaration that the person no longer qualifies for the po-
- 3 sition.

- "(e) A director resigns from a position. A position becomes vacant under this paragraph upon the department's receiving notice of the resignation.
- 6 "(f) A candidate who received the most votes at an election, or an appointee, refuses to take the oath of office as a director.
 - "[(8)] (9) A director position that becomes vacant before the scheduled expiration of a term shall be filled by appointment by a majority of the remaining directors. However, if a majority of the director positions are vacant or if the remaining directors cannot agree on an appointee, the department shall make an appointment to fill the position.
 - "[(9)] (10) An appointment under subsection [(8)] (9) of this section shall end on January 1 next following the first general district election held after the appointment. If the appointment ends under this subsection before the January 1 that would normally complete the four-year term of office for the position, the position shall be placed on the ballot at the next general election as provided under ORS 568.530 to fill the position for the remainder of the four-year term."
