1 On page 14 of the printed A-engrossed bill, delete lines 35 through 45 and 2 delete page 15 and insert:

SECTION 9. Notwithstanding any other provision of law, the General Fund appropriation made to the Department of Human Services by section 1 (2), chapter ____, Oregon Laws 2023 (Enrolled House Bill 5026), for the biennium beginning July 1, 2023, for state assessments and enterprise-wide costs, is increased by \$205,644 for two positions in the Office of Training, Investigations and Safety.

"SECTION 10. Notwithstanding any other law limiting expenditures, 9 the limitation on expenditures established by section 2 (8), chapter ____, 10 Oregon Laws 2023 (Enrolled House Bill 5026), for the biennium begin-11 ning July 1, 2023, as the maximum limit for payment of expenses from 12 fees, moneys or other revenues, including Miscellaneous Receipts, and 13 Medicare receipts and including federal funds for indirect cost recov-14 15ery, Social Security Supplemental Security Income recoveries and the Child Care and Development Fund, but excluding lottery funds and 16 federal funds not described in section 2 (8), chapter ___, Oregon Laws 17 2023 (Enrolled House Bill 5026), collected or received by the Department 18 of Human Services for shared services is increased by \$339,279 for two 19 positions in the Office of Training, Investigations and Safety. 20

"(3) The quarterly report described in the amendments to ORS
419B.019 by section 7 of this 2023 Act, is first due on January 1, 2024.
