No on SB704 No to Universal Healthcare

Do not allow this state to continue down a disastrous path of Universal Healthcare, including setting up a Universal Health Plan Governance Board.

MORE government takeover is rarely to answer, especially by the Oregon State government. This is just one more example of our state's transfer of money from those who work for it to those who don't care to be a contributing member of society. I want to see that those who are unable to care for themselves get the care they need. But we are already doing that. Have you been to an emergency room lately? Any argument that there isn't already access to healthcare for every Oregon citizen (and non-citizen) falls flat on its face. I have been to an emergency room within the last year and waited hours while staff assessed those waiting and addressed their needs according to medical necessity and urgency. The impending longer waits alone aren't the complaint. - <u>Pay more</u>. I put zero credibility in the September 2022 Final Report as related to anticipated cost.

Quoting the report, "The Task Force also assessed examples of revenue strategies based on the assumption that funding will come from existing sources, such as federal and state funds for Medicare and Medicaid. Oregon will need new revenues so that out-of-pocket costs, including premiums, deductibles, and co-pays, are eliminated."
