Dear Honorable Chair Dexter and members of the Committee:

For the record, my name is Kevin Cronin, I live in Eugene and serve as the director of Member Relations and Industry support for Housing Oregon. We strongly urge you to pass HB2001.

Housing Oregon is a membership-based statewide association of over 80 affordable housing community development corporations (CDCs) committed to serving and supporting low-income Oregonians across the housing needs spectrum – from homeless to homeowner.

Housing Oregon has long advocated and organized through the community reinvestment process for banks to create a fund for pre-development grants and loans. We are thrilled the Oregon Legislature is considering HB2001, which will create a fund to do exactly that for moderate income developments. We would like to see a similar fund targeted to low-income predevelopment. Reasonable lines of credit for predevelopment work is one of the best ways the state can support our members, the mission driven nonprofits working tirelessly to build new affordable housing.

Today, every family entering a new housing development and every person proudly holding a key to their own front door for the first time in years, is at risk of being a few dollars short on rent and losing everything to eviction. We can't let that happen.

Our members have substantial rental housing portfolios, and we appreciate the work that tenant advocates and landlords have done to reach a compromise on the eviction provisions within this bill. Reducing evictions is an essential part of our housing and homelessness response.
