Opposition of HB2107

OHA is a citizen Agency only. They are not part of a legislative body to enforce ANYTHING to the 'public' of Oregon and cannot be ASSIGNED to act as a legislative body regarding OREGON ELECTIONS. This goes far beyond OHA's scope. (ORS 431A.015)

The bill states, "the authority may not provide to the secretary any electronic records demonstrating that a person is not a citizen of the United States," WHICH IS ONE of the criteria for being an ELIGIBLE voter. Then the secretary is to obtain an electronic signature from the Department of Transportation if not provided by the authority. If (DMV) Transportation has the signature, that should mean they have already been registered under motor voter. Is there no check for duplication?

Oregon is far behind on any transparency, effectiveness, and has completely lost its citizens trust in their (the peoples) elections and who represents them.

The second part of HB 2107 establishes a pilot program at Powder River Correctional Facility to require that each adult in custody be granted an updated state identification card and voter registration upon release. The Adult Custody Programs aimed towards rehabilitation include civic responsibility to re-enter society. "If" the convicted take their rehabilitation seriously, voter registration or re-registration should be presented as a PRIVILEGE to seek out their right to vote, not be force onto them. Once this system is set up, it makes it easier to then pass voting for prisoners in the name of "equity" for the convicted even though those convicted are not contributing to their society, but rather society paying for all their states convicted from the working citizens tax dollars.

This is an assigning of a legislative body AUTHORITY over VOTER REGISTRATION. Effect of amendment: defines qualified entity as Oregon health Authority, State Department of Fish and Wildlife, gun dealer, county sheriff, or Secretary of State (SOS).

How is this relative to the 'AGENCY' role as a health department in the workplace (OHA) or Fish and wildlife in licensing?
