Re: Support for House Bill 2001

Dear Chair Dexter, Vice-Chairs Gamba and Helfrich and Members of the Committee,

On behalf of Our Just Future, please accept this testimony in strong support of HB 2001. This bill addresses our state's urgent housing needs and long-term housing supply challenges with immediate action on several fronts.

At Our Just Future we counter the forces that keep people and communities in poverty by building relationships and assets that create opportunity – today and for future generations. We operate a broad range of anti-poverty programs, from emergency shelter to permanent affordable housing, after-school mentoring to career support – and a lot more in between. Through this work we envision vibrant, healthy neighborhoods where all people can share in the security, hopes and advantages of a thriving, supportive community.

In this moment, we look to our leadership to create a future in which every person has all of their basic needs met, including housing. As evidenced by the many housing policies that emerged during the global pandemic, Oregonians are making real, meaningful change at a policy level. This is no time to stop.

HB 2001, incorporating the amendments being considered by your committee on February 23, includes several important elements of the response to our statewide housing crisis. The bill will:

- Provide essential and reasonable negotiated improvements to Oregon's eviction statutes to promote stability and payment rather than displacement and eviction.
- Expand investments in youth homelessness prevention, prioritizing services for school-aged children who are homeless or at risk of homelessness, and their families.
- Provide \$20 million in grant/loan funds for the construction of low-cost modular housing in wildfire-affected areas and for low- and moderate-income households.
- Provide \$3 million in seed financing for the construction of affordable workforce rental housing.
