My name is Karen Saxe and I work for DevNW, an affordable housing development and counseling agency serving Lane, Linn, Benton, Lincoln, Marion and Clackamas Counties.

During the Public Hearing on SB 937, a question arose about the current stock of Community Land Trust homes, funded by the LIFT Homeownership program. With support from OHCS, below is a table identifying funded projects including: their location, number of units for each, project progress and the housing development agency leading that development. Additionally, OHCS has developed a map of these projects that is also included for reference.

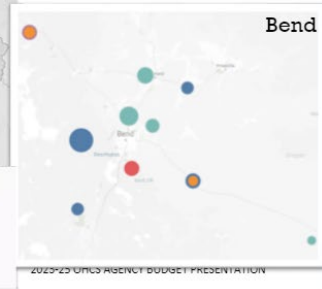
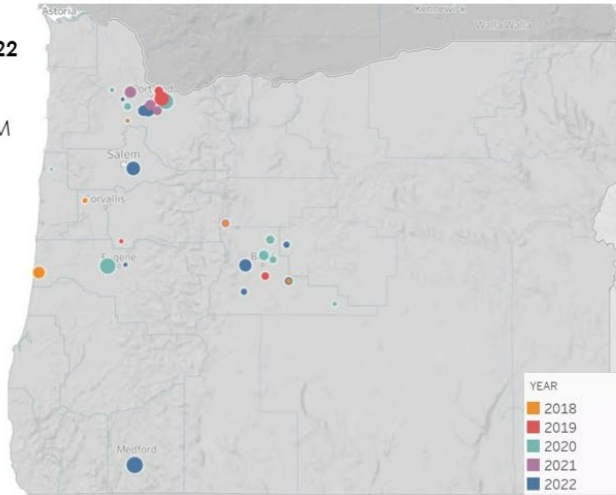
