\*\* [SB 5511 (2023)] is a ghastly waste of taxpayer monies to FUND the Oregon Housing and Community Services Department's welfare state. [SB 5511] states: "... SECTION 5. *There is appropriated to the Housing and Community Services Department*, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$155,800,792 for debt service for bond-related activities." Why is there "No" mention of the "Total indebtedness?"

#### Let us start with the Funding of [SB 936].

**[SB 936]** states, "...SECTION 5. In addition to and not in lieu of any other appropriation, *there is appropriated to the Housing and Community Services Department*, for the biennium beginning July 1, 2023, **out of the General Fund**:

(1) The amount of **\$100,000,000**, to provide grants under section 2 of this 2023 Act.

(2) The amount of **\$30,000,000**, to provide financial assistance under section 3 of this 2023 Act.

(3) The amount of **\$20,000,000**, to provide grants under section 4 of this 2023 Act."

#### \*[SB 936], if Enrolled takes [\$150,000,000.00] out of the GENERAL FUND.

\*Despite, the Housing and Community Department's financial obligations require, [\$155,800,792.00] GENERAL FUND-TAXPAYER MONEY FOR DEBT SERVICE.

One would think, if only for a nanosecond, the Debt Service obligations defined in **[SB 5511]** should be enough reason to shutter the Housing and Community Services Department and therefore abandon **[SB 936]** to begin, to pay-off the debt incurred-**Again, the Total indebtedness is intentionally NOT stated**...probably, because of its' size.

**[SB 936]**'s "SECTION 2"...The "Housing and Community Services Department" **distributes the Housing Grants to**: "...the grantee must: (a) **Be or partner with a culturally responsive or culturally specific organization**; (b) Demonstrate strategies to make eligibility for purchasing a home available **to historically underserved communities, including communities of color**; and (c) Sell each home to a low income household that is a first-time home buyer that will occupy the home as its primary residence...." **[SB 936] codifies "Systemic Racism" into Oregon Law.** 

# Does [SB 936] obey, The 14<sup>th</sup> Amendment of the Constitution of the United States of America?

"... (4) The department may award larger grants per developed home under this section for homes that will be made affordable to lower income households, but with the target of awarding grants under this section that average \$200,000 per developed home. (5) The department shall give preference to grantees: (a) That finance or arrange financing of the sale of the home at below-market interest rates or with down payments of less than \$10,000; or (b) That use a community land trust model in which the grantee will own the land subject to a ground lease of no less than 90 years."
