Chair Neron, Members of the House Committee on Education, my name is Johnie Ferro, and I serve as the principal of the Willamette Career Academy. As a representative of our 250 students, I ask that this committee support HB3236, ultimately providing \$2,850,000 per biennium to this unique approach to education.

You see, I witness innovation, collaboration, and achievement every day. Our students have found a program of study that aligns with their career goals and have access to teachers with industry expertise and a true commitment to teaching the next generation of workers. Studies show that students with a strong connection to their school and at least one trusted adult are more likely to experience academic success and mental and behavioral health benefits like reduced absenteeism, increased motivation and engagement, and reduced emotional distress. I'm proud to say that when we asked our students about their experience over 80% of them shared that they feel connected and have a strong sense of belonging at WCA.

That sense of belonging flows from their experience in WCA classrooms to increased success in completing their Career Technical Education and High School diplomas. Last year, our students had a graduation rate of 97.65%, over 36% higher than the state average. As a result, WCA students are walking across the graduation stage with more diplomas in hand. At the WCA, students earn college credits, certifications, and licensures.

Our goal is to give all students a competitive advantage, which is especially important to students from historically underrepresented groups and underserved rural communities. WCA supports a diverse student population, with 55.9% identifying as Black, Indigenous, and people of color. At the WCA, all students are welcome and united in shared goals for career readiness.




#### Who We Are

The Willamette Career Academy (WCA) is harnessing the power of connection and collaboration and has become a successful regional hub for career/technical innovation. The program continues to grow and currently serves students and business partners in Marion, Polk, and Yamhill counties.

Entering its second year, the WCA is now offering six different educational programs to help address the demand for highly-skilled workers in our region, as our invested industry partners requested. The educational programs are Cosmetology, Health Services, PAPÉ Diesel Technology, Construction Technology, IT/Computer Science, and Freres Manufacturing Technology.

The Willamette ESD (WESD), representing the region's 21 school districts, has been operating the WCA and has plans for continuous improvement for the school's long-term success.



#### First Large Scale In-State Model of Regional Education

While other states have implemented regional career and technical center model, this project represents the first of its kind in Oregon. WESD is proud to demonstrate the value and viability of providing more opportunities and hands-on learning that students crave and industry demands.

#### **Project Costs**

We'd like to ask the Oregon Legislature to commit \$2,850,000 dollars to the Willamette Career Academy for the 2023-25 biennium. This funding will provide operating costs, work-based learning, internships, apprenticeship opportunities, and access to high-quality educators to teach our students.

#### Regional Impact

District superintendents and school boards have fully committed to the WCA and have supported it during its first year of welcoming students. This state-of-the-art school prepares students for in-demand jobs in six popular programs and can also provide access to further education and training in those career pathways. This ongoing influx of highly skilled workers into our region will make our local counties more attractive to business and industry investments. The WCA plans to support over 450 students when operating at full capacity.

Industry partners have lined up with financial and programming support, demonstrating the urgent and intense need for skilled labor. Programs like the WCA showcase Oregon Legislators' commitment to career and technical education and providing the next-generation workforce that is desperately needed.

### How House Bill 3236 Qualifies for Funding Under the Statewide Education Initiatives Account

The Willamette Career Academy (WCA) was created to support regional school districts in meeting Oregon's education needs as outlined in the Statewide Education Initiatives Account (SEIA), with a focus of creating more options for a well-rounded education for historically underserved students through the Willamette region.

#### The WCA consistently demonstrates SEIA's purpose, growth targets, and focus areas.

#### Meet student's mental and behavioral health needs

Students who have a strong connection to their school and at least one trusting adult are more likely to
experience academic success, reduced absenteeism, increased motivation and engagement, and reduced
emotional distress. Over 80% of WCA students surveyed said they feel connected and have a strong sense of
belonging at WCA.

#### • On-time graduation, Ninth Grade on-track rates, and 5 year completion

 The WCA has demonstrated a graduation rate of 97.65%, compared to Oregon statewide graduation rates at 93% for Career Technical Education (CTE) high school completers and 61% for high school students not involved in CTE.

#### • Increase academic achievement for students, including reducing academic disparities.

• The WCA reduces academic disparities by supporting a diverse student population (55.9% of students at the WCA identify as Black, Indigenous, and people of color (BIPOC) and closes the achievement gap between rural and urban high school students. The WCA does this work by offering accredited classes through a consortium model where regional high schools can participate in high-quality programs equitably with their peers in larger districts. WCA students can gain up to 24 credits toward their degree.

#### Regular Attender Rates

 Career Technical Education programs like the WCA improve attendance because students are engaged in their learning and invested in the career outcomes it can lead them towards.

#### Well-Rounded Education Opportunities

The average high school offers 3.1 Programs of Study. The WCA allows rural and underserved communities access to 6 highly technical programs that lead to certification, licensure, and accelerated learning opportunities via pre-apprentice pathways, college articulated classes, and Advanced Placement courses. These pathways lead to high-wage, high-demand jobs within the industries of our region and across the state. In addition to high academic standards, WCA students engage in career-connected learning experiences with industry and workforce partners.

The funding requested from the Statewide Education Initiatives Account will change lives and communities through investing in students' success. This investment pays dividends through creating a robust, technically-skilled, and stable workforce for Oregon's industries. Funding Willamette Career Academy is consistent with the goal of the Statewide Education Initiatives Account to pave the way for students' success and a stronger Oregon.

My name is Abel Anaya and I'm a senior at Gervais High School as well as a part of the Health Services program at Willamette Career Academy (WCA). WCA has been such an extraordinary opportunity that I've been lucky to be a part of. My whole life, I've known I've wanted to help people, just not what career I would want to pursue. Then I heard about this program and thought, "maybe this could be my calling", and I couldn't be more right. #### **Dylan Wagoner, Junior at Cascade High School**

My name is Dylan Wagoner and I'm a Junior at Cascade High School and also enrolled in the Computer Science/IT program at Willamette Career Academy. Since joining WCA it has expanded my knowledge of the IT world and given me materials that I would have never had access to otherwise. Coming from a low income household, I thought I would never have the financial resources or learning opportunities needed to attend an Information Technology program but WCA has opened more doors than I thought possible. When covid hit during freshman year, I struggled a lot with online learning and the pressure of what I want to do in the future. My GPA tanked and I had to go to an opportunity center where I needed to make up 2 years worth of credits in 1 year. During this time I heard about Willamette Career Academy from a WCA staff member doing presentations at schools. After a lot of thought I realized I wanted to go into the tech field and Willamette Career Academy had just created a Computer Science/IT

Program that I applied to and it has been one of the best choices I've ever made. Since the beginning of the year I have learned so much about different fields in the Tech world. It has given me a better opportunity to look at what specific field I want to join and the materials and education to do so; I want to be an IT field technician and this program has given me a headstart in my career field of choice.

#### Jazerei Lei Pajela, Junior at Woodburn High School

Chair Neron, Vice-Chairs Hudson and Wright, and members of the Committee,

My name is Jazerei Lei Pajela. I'm a junior at Woodburn High School and I'm currently enrolled in the Manufacturing Program at Willamette Career Academy. When first applying at WCA I was given the chance to explore my interests in all of the programs, my first choice being the Health Services program because I wanted to go into biomedical engineering. My second option was the Manufacturing program because it was still related to careers in the engineering field. At first I was disappointed to not be in Health Services, but as I was exploring the Manufacturing program I realized that it still offered me all the materials and tools needed to still fulfill what I wanted to do in my future.

To me WCA is more than just a school, as the environment is vastly different than you would find at any regular school. For me, before attending WCA I was struggling a lot with the monotony of school. Every single day the same routine, and I was struggling to find a purpose in a lot of what I was doing. I started to question what I wanted to do in my life, because of the daily monotony. I asked myself if there was any way that I could expand on what I wanted to do based upon my interests. One day I heard about WCA and I thought that I could really see myself there. Now that I'm at WCA I'm always moving around, and that's not just busy work! In the manufacturing program every single bit of what I'm learning is pertinent to my future, and I feel a closer connection with all the content and hands-on experiences.

It's not just the content that I feel closer with, it's also with the staff and my peers as well. The staff at WCA do a wonderful job at making the program feel as welcoming as possible, and it's wonderful to be around classmates who all have the same interests. Being in such a positive environment has really made for an amazing place to learn, and I find myself wanting to do better because I know it will help me. When I go to school everyday, I have something to look forward to, and that's all I could ever ask for. Being given the opportunity to show up there everyday is a privilege, and I know that I'm lucky to have the resources that WCA has to offer. I'm proud of what WCA is, and I'm proud of my program. #### Chair Neron, Members of the Committee:

As school leaders representing a partnership with the Willamette Career Academy (WCA), we ask that the Oregon Legislature make a commitment of \$2,850,000 to the WCA for the 2023-25 biennium. We believe in a thriving Oregon through the success of our students, and we believe in supporting WCA through HB 3236.

The success of HB 3236 is more than continuing funding to the Willamette Career Academy – it's continuing the state's commitment to improving access and opportunities for students in historically underserved communities and investing in the success of Oregon students. As school leaders, we are committed to representing the needs and interests of our students. We value the work of the WCA and we value the state's investment in our students.

Serving Marion, Polk, and Yamhill counties, the WCA is the first regional Career Technical Education program of its size in Oregon. The WCA provided six different career educational programs for 250 students in the 2022-23 school year, a student base where nearly 57% of students were students of color and 53% of students were female. The WCA exceeds even the high expectations of Career Technical Education programs, with 97.6% of their students graduating on time in the first year. Since its first year, the WCA has doubled its programs and increased its partnerships with business and industry.

United in public and private support, the WCA has the active involvement of local industry partners, such as Knife River, Papé Machinery, Freres Lumber, Salem Health, and MaPS Credit Union. The inclusion of industry partners allows WCA students to engage in a sustainable school-to-career pathway – connecting businesses with skilled employees and teaching students the skills needed for high-paying, in-demand local jobs. This ongoing influx of highly skilled workers into our region will make our local counties more attractive to business and industry investments.

In order for this student success and dynamic growth to continue, the WCA needs support. The funding of HB 3236 will be allocated to the WCA's operating costs, work-based learning, internships, apprenticeship opportunities, and access to high-quality educators who teach our students. As it grows, the WCA will be able to support over 450 students at its full capacity.

We believe in the Willamette Career Academy and the positive impact it has had on our students. We respectfully ask you to support HB 3236.

HB 3236 would allow expenditure of Statewide Education Initiatives Account funds for regional and technical education programs. Specifically, the bill allocates significant funding for the Willamette Career Academy that would allow continued exposure of students to health care careers.

Salem Health partners with Willamette Career Academy's basic nursing skills program, co-employing their nursing instructor and participating in the ongoing development and review of the program's curriculum. In the fall of 2022, 29 second-year students in the program participated in a pilot project to provide students a chance to observe a variety of health care careers. Over 12 weeks, students had opportunities to shadow our staff in multiple units, including the ICU, emergency department, respiratory therapy, imaging, and volunteer services. Chair Neron, Members of the Committee:

I'm writing today in support of House Bill 3236 because Oregon students deserve and need a well-rounded education that is career-focused and individualized to their goals. If the pandemic has taught me anything, it's that schools should look and feel different than the traditional model.

HB 3236 would allow the expenditure of Statewide Education Initiatives Account funds for regional and technical education programs. Specifically, the bill allocates significant funding for the Willamette Career Academy that would allow continued exposure of students to in-demand, local, and high-paying industries, including healthcare, computer science/information technology, manufacturing, construction trades, cosmetology, and diesel technology.

The Willamette Career Academy harnesses the power of connection and collaboration and serves as a regional hub for career and technical innovation by supporting the Willamette ESD and school districts throughout Marion, Polk, and Yamhill counties. As the principal of the WCA, I watched the WCA move from concept to reality through the robust participation and enthusiasm of our students and industry partners.

The impact of programs, career-connected learning, and work-based experiences on our students is profound. Destynie Morrison, a Senior at Woodburn High School and second year WCA student, shared this:

"In 2016, my mom passed away, and my dad was really sick. I kept doing my best at school, but nothing made me feel like I was doing a good job. When I was in the eighth grade, my dad passed away too, and I wanted to drop out of school because I saw no point in doing something if they weren't around. But then I looked at my little sister and decided to keep on going for her, to show her that if I can do it, she can too. Thanks to hard work and WCA, I am now on track to be a first-generation high school graduate and a first-generation college student.

Every day at WCA, I feel like I am part of a new family. I love how we are all so close and treated not only as individuals but as a team! There is so much support here for everyone, whether it's academically or emotionally, there is always someone there to help you!!

WCA has helped prepare me for my future in so many ways. By the end of this year, I will be able to sit for licensing boards to earn my license in Hair Design. I plan to work as a hairstylist while I continue my education at Western Oregon University this fall.

Without WCA, I don't know where I would be. The team at WCA is amazing. They make this more than a school, it is also a family. Thank you so much to all the donors, supporters, teachers, and administrators who make this place a home where students can truly discover their best selves."

I'm excited to watch these generations of students continue to grow and strengthen our communities through their passion for their industries, commitment to continuous improvement, and the solid foundation they earned through their work at Willamette Career Academy. By joining with 11 other school districts and industry partners, our students have the chance to gain hands-on experiences in a variety of career and technical fields. By participating in WCA, we're providing education and career opportunities to our students that they may not have otherwise and we value the equity bolstered by those opportunities. Students who enroll in the program for two years, graduate with initial certifications that allow them to go right to work in their industry or with the prerequisites that easily transition to a trade school, 2-year or 4-year college.

The last few years have been really challenging for our students as virtual learning and career uncertainty eroded their sense of belonging, motivation, and hopefulness. At Gervais, we're dedicated to creating support for students' mental health and vision for the future and the Willamette Career Academy is a block that we depend on for building our momentum and success. As a superintendent with a bright generation of students, I ask for you to stand by one of the keys to our success and support Willamette Career Academy through House Bill 3236.
