To Whom it May Concern,

House Bill 2002 has come to our attention.

Gender-affirming treatment offered to young adolescents is child-abuse at the highest level. It flies in the face of the proven science of our DNA and our biological make-up.

It does not protect our children but exploits a child's innocence while they are growing and changing so rapidly. Children may want to be a 'pirate' today but may become a lawyer when they grow up; today's 'tomboy' may become a loving wife and happy mother. Most children outgrow any gender dysphoria.
