Dear Chair Noose, Committee Members:

My name is Jonathan Polonsky. I am the President and CEO of the Plaid Pantry convenience store chain. Plaid Pantry was founded in Oregon in 1963 and we currently operate 103 Oregon stores primarily in Clackamas, Lane, Multnomah, and Washington counties. I will be participating in the public hearing on March 21, 2023 to voice our opposition to HB3090. It is extremely difficult to present a meaningful statement on such a complex topic in only two minutes. I hope you will review the attached appendix and consider the content as part of your decision-making process. These images illustrate the lack of enforcement that exists more than a year after HB2261 was passed, which made online tobacco sales illegal. I will add some additional examples during my oral testimony.

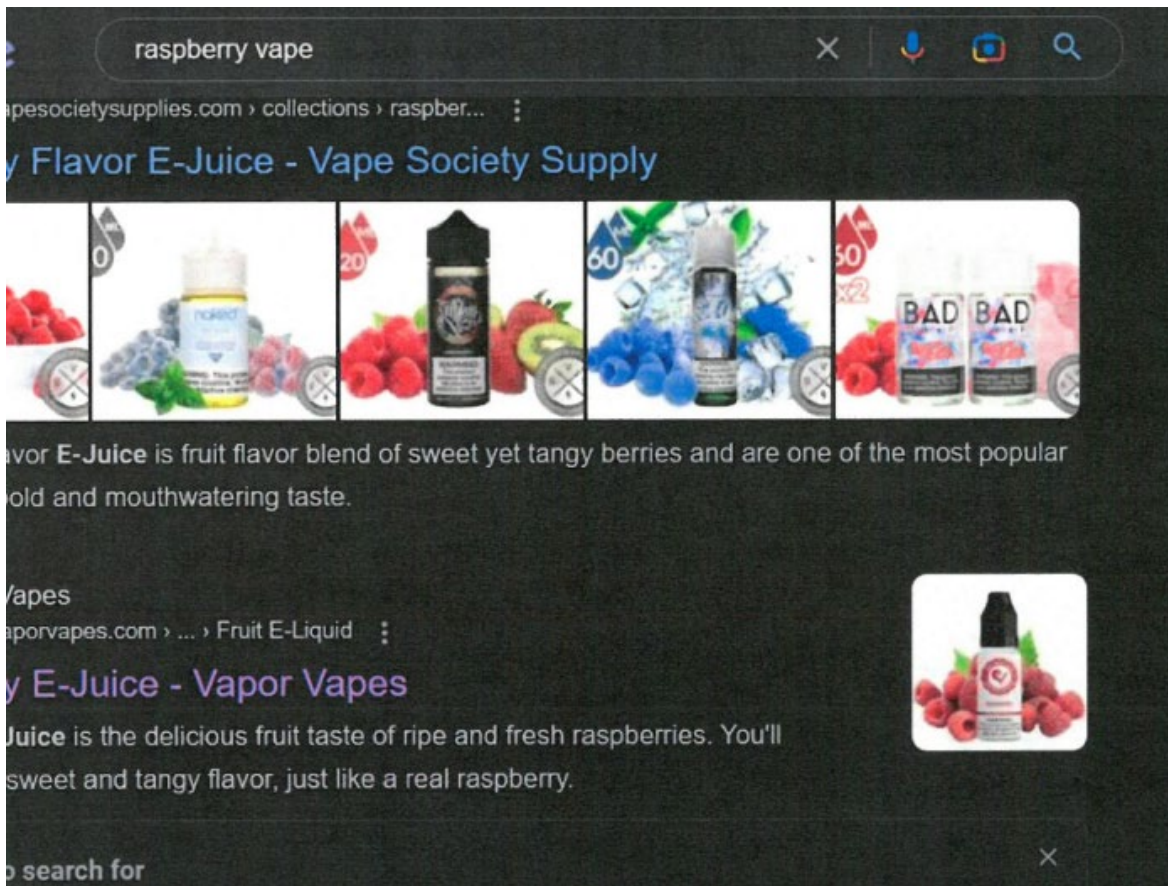

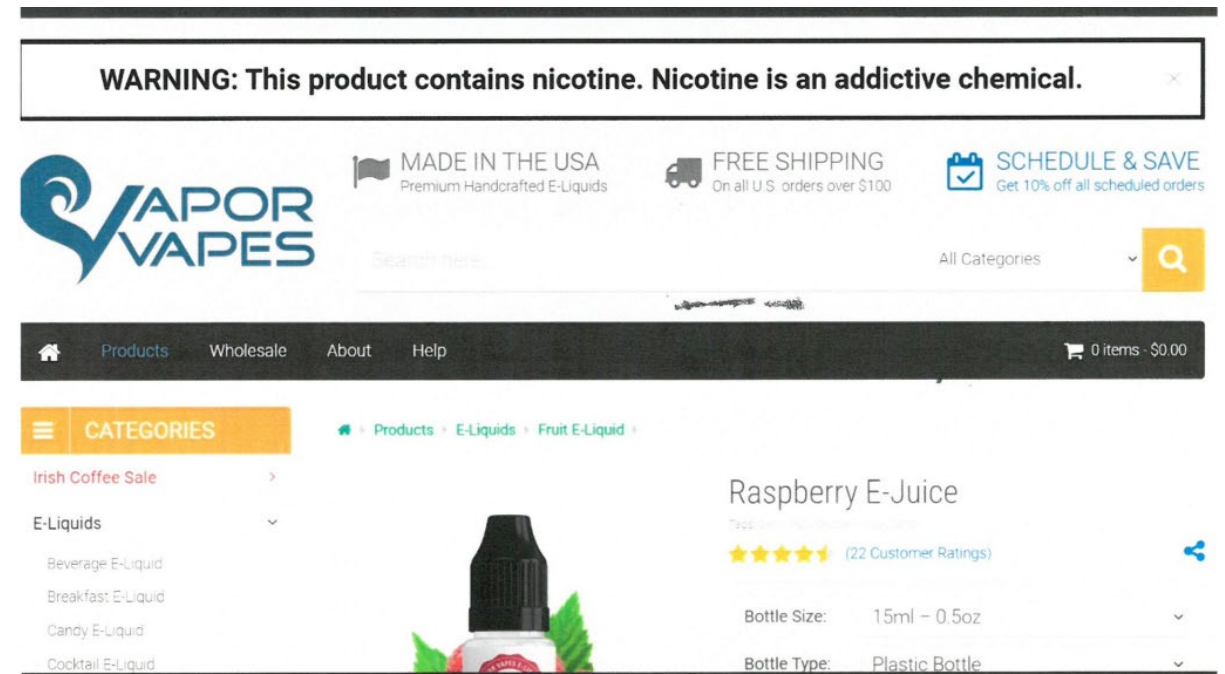

1. Open the bottle of e-liquid.
2. Shake the bottle before using.
3. Unscrew the cap.
4. Fill your receptacle.
5. Make sure that all components are screwed together before using.

Storing Guidelines & Shelf Life:

- Keep your e-juice away from warmer temperatures and sunlight.
- Always store e-liquids in a cool and dark place.
- Be sure to check that you have sealed your e-juice tightly before placing it back in the storage space.

If your e-juice is stored correctly you can extend the shelf life to 24 months.
