Dear Senate Committee on Natural Resources,

I have just been notified that Senator Golden, Chair of the Natural Resources Committee, is planning to introduce a devastating amendment to the SB 85 -1 bill that would limit the factory farm moratorium to only large-scale poultry operations. This newly proposed amendment will put the Original Factory Farm Moratorium Bill (Senate Bill 85-1) at risk of being severely weakened. SB 85 with the proposed -1 amendments would prohibit all new and expanding factory farms in Oregon, not just large-scale poultry operations.

If SB 85 -1 passes with Senator Golden's newly proposed amendment that would limit the factory farm moratorium to only large-scale poultry operations, it would fail to address the myriad environmental, public health, animal welfare, and other negative effects that Oregon faces from other types of factory farms, such as mega-dairies and feed lots for cows, etc.

This is not acceptable, therefore I am respectfully urging you to oppose Senator Golden's newly proposed amendment and show continued support for the Original Factory Farm Moratorium Bill - SB 85 -1.
