6. I understand that I give up all of the rights user in baragraph #5 above when I enter an admission to the allegation(s). I understand that I also give up: (1) any defenses I may have to the allegation(s); (2) objections to the consideration of evidence concerning my guilt; and (3) challenges to the accusatory instrument.

I understand that if I enter an admission, the underlying probation, diversion or deferred prosecution may be revoked and I may be convicted of the underlying charge (if I have not already been convicted), and sentenced up to the maximum allowed by law. I understand that the judge may impose the same punishment as if I entered a denial of the allegation(s), had a hearing, and was found guilty of the allegation(s).


