HB3596 / Surgical Tech Apprenticeship Workforce TECHNICAL FIX: Bi-Partisan Support (Passed 59-1 and 20-2 in 2022) Rural & Urban!

Your hospitals and surgery centers are struggling to fill positions and retain these essential operating room support staff, even at salaries starting at \$25 - \$32 an hour or more. Some facilities have over dozens openings, and the shortages are forcing facilities to <u>delay care or assign</u> the Surg Tech tasks to skilled nurses, taking them away from their important duties.

Uses the Proven Apprenticeship Model

HB4106 -1 was passed to create an <u>apprenticeship</u> program through BOLI to allow potential surgical techs to "earn while they learn" and gain <u>the necessary education and valuable experience</u>

in direct patient care. The program will utilize the National Center for Competency Testing to accredit the program and provide high testing standards. Legislative intent for HB4106 -1 was to allow for <u>work-based skills</u> <u>development</u>, similar to many other proven models, including for Certified Medical Assistants and Certified Nursing Assistants. And it maintains the highest safety and oversight standards.

During rulemaking last fall, Oregon's DOJ determined that legislative counsel had put one word in the wrong place. Thus, the rules were approved but the apprenticeship program the Legislature approved by huge margins can't go into effect until that's fixed. Until then, no apprenticeship can start because the "and" was determined to require a 2-year degree AND an apprenticeship. <u>Clearly that was not legislative intent</u>. Chair Nosse introduced HB3696 to make that technical fix.


