I am a lifetime Oregon resident, born and raised and I have always been a lawabiding citizen. In the State of Oregon, the crime rate has gone up exponentially and local law enforcement has been understaffed. There are carjackings, home invasions, muggings, criminals running from the police and hiding in and around people's houses. These criminals are very often armed and dangerous and have no respect for human life. My wife was just involved in a hit and run where the suspect had a criminal past.
