In its current form, Oregon's Fish and Wildlife Commission does not adequately represent the diverse ecological regions of the state due to its reliance on political boundaries. A more sensible approach would be to use natural river basin boundaries, with commissioners knowledgeable about their respective regions. Support for HB3086 is critical in revising the current statute to allow for these changes. By ensuring the remaining two members are from either side of the Cascade range, we can prioritize wildlife and natural resources in the OFW Commission.
