Current Law (ORS 413)

- SECTION 2. Sets composition of the Board
- > **SECTION 4.** (1) Establishes the of the Board to:
 - (a) Be the policy making body and oversight for the OHA and all Authority's departmental divisions.
 - (b) Develop and submit a plan to the Legislative Assembly to provide and fund access to affordable, quality health care for all Oregonians.
 - (c) Develop a program to provide health insurance assistance to all low and moderate income individuals who are legal residents of Oregon.
 - (d) Publish health outcome and quality measure data collected by the OHA..... (for) each CCO, health benefit plan (in the) insurance exchange or offered by OEBB or PEBB
 - (e) Establish evidence based clinical and practice guidelines that may be used
 - (f) Approve and monitor community centered health initiatives consistent with public health goals, strategies, programs and strategies established by the OHPB
 - (g) Establish cost containment mechanisms to reduce costs
 - (h) Ensure health care workforce is sufficient...
 - (i) Work with Congressional Delegation to advance changes in federal law or policy to advance Oregon's reform plan
 - (j) Establish health benefit package (prioritized list) as basis for health benefit plans.....
 - (k) Investigate and report to Legislature the feasibility and advisability future change to the health insurance market...
 - (I) Meet cost-containment goals by structuring reimbursement rates to reward comprehensive disease management, quality outcomes and the efficient use of resources by promoting cost-effective procedures, services and programs including, without limitation, preventive health, dental and primary care services...
 - (m) Oversee the expenditure of moneys from the Health Care Provider Incentive Fund to support grants to primary care providers and rural health practitioners, increase the number of primary care educators and to support efforts to create and develop career ladder opportunities.
 - (2) Board is authorized to:
 - (a) Subject to Governors approval, organize and reorganize the OHA as it considers necessary to properly conduct the work of the authority
 - (b) Submit directly to the Legislative counsel request for measures... and to file measure directly to the Legislature.
 - (3) Seek Federal approval for waivers to perform its duties.
 - (4) This section not intended to be exclusive nor limit the duties, functions and powers imposed on the OHPB.

SB 1042 Additions & Amendments to Current Law (ORS 413)

- ➤ <u>SECTION 1</u>. (1) Shall produce a comprehensive report on the Oregon Integrated and Coordinated Health Care Delivery System that includes analyses of the costs of the system and health outcomes and the success since 2012 in achieving:
 - (a) The goals of the system described in ORS 414.570 (1) and (2);
 - (b) Payment reform and delivery system change as described in ORS 414.570 (3); and
 - (c) A reduction in health disparities and improved access to health care and improved

health outcomes for all Oregonians.

- (2) No later than December 31, 2024, the board shall submit the report described in sub-section (1) of this section...
- > <u>SECTION 2.</u> Modifies the membership of the Board to add expertise in health care delivery, finance, behavioral health and reimbursement, and primary care.
- SECTION 3. Creates for the OHPB
 - (a) A separate staff hired by the Board
 - (b) A separate budget for all functions of the Board
 - (c) Oversight of the Health Evidence Review Commission
- > **SECTION 4.** Duties
 - (a) Advance health care system transformation including bet mot limited to:
 - **(b)** Rulemaking authority and oversight:
 - Rulemaking by the OHA
 - OHA compliance with State and Federal requirements including an adequate workforce for Medicaid recipients
 - Contracting with CCO's
 - Review and approval of submissions for waivers and state plan amendments
 - OHA's administration of the Health Care Cost Growth Target program
- ➤ **SECTION 5.** Clarifies the OHPB authority and oversight of the OHA's organization and management
 - (a) Approval for submission of legislative concepts to the Governor
- SECTION 6. Provide consultation and advice in the appointment of the Director
- > SECTION 8. Places the HERC under the OHPB
