Sponsors, Inc. is a national leader in the delivery of Reentry services, operating in Lane County. We offer a broad range of services—case management, employment assistance, housing, mental health services and mentoring—that people need in order to be successful upon returning to their community.

This system benefits all Oregonians by ensuring that criminal investigations and trials are conducted in a manner that protects the accused's constitutional rights. The right to counsel ensures that all aspects of the criminal justice system – district attorneys, law enforcement agencies and defense attorneys – are operating on equal footing.

No matter who we are or how much money we have, all Americans have a constitutional right to zealous legal representation. Those who do not have the aid of a lawyer who has the time, ability and resources to present an effective defense are more likely to be unfairly charged, detained and potentially even deported.

But today in Oregon, public defenders are overloaded with cases, meaning many low-income Oregonians who are disproportionately people of color, do not have adequate representation. To protect the constitutional right to a fair trial and the pursuit of justice, Oregon must ensure everyone has equal access to adequate legal representation.
