Please Support bill and Oregon EPPs working with TSPC to improve system for Oregonians

PLEASE STOP AUTHORITY FOR NEW CHARGES ON EDUCATION PREP PROGRAM CHARGES

- SB 129 (2021) gave TSPC the authority to establish fees to pay for program approvals for public and private Education Preparation Providers (EPPs).
- The proposed fees that the agency is intending to collect are both per institution (\$2,000 to \$20,000 for each institution) and per program (\$2,000 to \$6,000 for each institution).
- 50% of teaching licenses that go through TSPC are from EPPs outside of Oregon, yet these institutions would not have to pay these forthcoming fees.
- Oregon EPPs are nationally accredited (as required by the legislature) – TSPC does not do this work assuring quality programs:
 - Initial national accreditation is \$10,000+ dollars and many hours of time and resources
 - Yearly dues to national accreditors are \$2,900+
- Oregon EPPs are concerned that this agency action is the antithesis to stated goals of improving access, affordability, diversity, reducing barriers to entry, and growing the profession.
- Oregon EPPs have been actively and successfully involved in the Grow Your Own program and other initiatives to reduce barriers and provide new pathways while maintaining Oregon standards.
- Oregon EPPs are utilizing more resources to meet those shared goals and anticipate that additions of more fees will need to be passed to new students.
- With a charge per program, Oregon EPPs are disincentivized to develop more programs and alternatives pathways to continue reaching those goals.
- Proposed new program fees would only be charged to in-state EPPs. Out of state alternative pathways not only would be free of charges, but they do not have to meet accreditation standards or pay those costs.
- Oregon EPPs are being asked to do more and pay more and are at a disadvantage competing with out of state institutions.
- **Please protect Oregon Educator Preparation Programs.**
