As a member of Oregon's food and beverage sector, I am writing to express my strong support for the OSU Statewides' budget in HB 5025.

OSU Statewides contribute greatly to Oregon's food and beverage sector through applied research and distribution of knowledge through OSU's statewide Extension network. It is important that the OSU Statewides receive continued service level funding and receive focus on sustainable food systems.

- Oregon produced beer and wine create more than \$12.5 billion annually in economic activity to
 Oregon with 43,000 jobs that result in nearly \$2 billion in wages. As a business owner in this sector, I
 can testify that Food Science & Technology alumni have added greatly to this economic success. FST
 has a Fermentation Science degree that is critical and highly sought after by the fermentation
