## RE: OSU Statewide Public Service Programs

Dear Senator Steiner and Representative Sanchez,

Our coalition of diverse stakeholders would like to share our support for the Oregon State University Statewide Public Service Programs – the Agricultural Experiment Station, Extension Service, and Forest Research Laboratory. Known as "The OSU Statewides," these programs touch every corner of the state and serve all Oregonians by providing state-of-the-art research and community-based education to address real-world problems.

As stakeholders, we have been impacted by the inadequate state funding for the OSU Statewides. Underfunding has led to a loss of essential scientists and Extension educators. It has reduced critical research and Extension programming and services throughout the state. We have asked OSU to develop a legislative request that would rebuild lost capacity while also addressing the many emerging issues that face our communities.

In the 2023-25 biennium the OSU Statewides seek a \$50 million increase to sustain current operations, bolster capacity to meet critical needs in core mission areas and make strategic investments in support of a more resilient future for Oregon communities, food systems and natural resources. This includes:

- \$15.7 million to provide full base funding to sustain program and service levels. This reflects an 8.67% increase in operating expenses plus a \$2.2 million catch-up to restore a deficit from our 2021-23 allocation.
- \$34.3 million in strategic investments crafted to support food production, accelerate approaches to sustainable forestry and help all Oregonians and their communities thrive.

This investment will provide for much-needed personnel, new and expanded programming and other critical support. Strategic investments on top of necessary base funding will place research and Extension professionals in key areas to deliver comprehensive, coordinated and interdisciplinary programming that is adaptable and responsive to local needs. These proposed investments are informed by and centered on critical needs in and at the intersections of agriculture, forestry, public health and youth development.

Thank you for your service to the state of Oregon. We recognize you have big decisions ahead. Please continue to recognize OSU's land grant mission to serve all corners of the state by continuing to invest in programs like the OSU Statewides that have significant impact for all Oregonians.
