Re: Follow-up on House Bill 2238 -A3

Tobias Read State Treasurer

The Department of State Lands appreciated the opportunity to provide testimony on HB 2238 -A3 on Wednesday, April 26 and is pleased to offer additional information regarding the Common School Fund's ongoing subsidy of Oregon's removal-fill permitting process.

Current fees related to adding and removing materials in wetlands and waters of the state are a removal-fill permit fee and a wetland delineation report fee. HB 2238-A3 would allow the DSL Director to establish these fees via a rulemaking process and adopt new fees in rule.

## **Common School Fund Subsidy of Removal-Fill Permits**

The maximum removal-fill permit fee is currently \$1,470. On average, the Common School Fund expends \$1.65 million annually to cover the cost of processing removal-fill permits. Average cost recovery is 25 percent.

## **Common School Fund Subsidy of Wetland Delineation Reports**

Wetland delineations precisely map the boundaries of wetlands or waterways to identify areas where removing or filling materials will require a DSL permit. A DSL-approved wetland delineation report is a required element of most removal-fill permit applications.

The wetland delineation report fee is currently \$540. On average, the Common School Fund expends \$673,000 annually to cover the cost of processing wetland delineation reports. Average cost recovery is 18 percent.

## **Total Common School Fund Subsidy of the Removal-Fill Permitting Process**

In total, DSL's administration of removal-fill permits and wetland delineation reports costs the Common School Fund an average of \$2.3 million annually. Fees charged cover, on average, 23 percent of the annual cost to administer the regulatory removal-fill permitting process.

The total combined revenue and expense costs for the past six years are below.
