

Testimony on HB 3564A

Senate Committee on Education May 2, 2023

Chair Dembrow, Vice-Chair Weber, and members of the Committee. My name is Kyle Thomas and I am the Director of Legislative and Policy Affairs for the Higher Education Coordinating Commission (HECC). Thank you for the opportunity to submit testimony on HB 3564A.

Once a biennium, HECC introduces a bill to make minor and technical modifications to statutes pertaining to higher education and workforce issues. These changes have no fiscal impact, and no or highly limited substantive impact. Primarily, this bill makes small changes to codify current practices, update terminology, or makes technical language changes that don't merit standalone legislation. The following table summarizes the changes included in the bill, and the -A3 amendment:

1	1	Updates the membership of the appointed Higher Education Coordinating Commission to account for the addition of the 6 th congressional district by creating a dedicated slot for a 6 th CD representative and reducing the number of at-large Commission slots by one.
2	2	Clarifies that the alteration to the membership of the Commission applies when one of the at-large positions comes up for reappointment, and that the change does not require the removal of a current Commissioner.

18	8	Emergency clause, added to ensure that student complaints being investigated today are properly before the Commission.
