Subject: Cost-Effective Ways to Increase Preschool Access through Outdoor Preschool Licensure (HB 2717-1)

Dear Joint Ways and Means Committee,

We are a group of advocates asking for your support on House Bill 2717-1 to establish Outdoor Preschool Licensure. The following points illustrate why **HB 2717-1** is a cost-effective option for the state, providers, and families that expand childcare across the state.

#### State:

- Outdoor preschool licensure is a cost-effective way for Oregon to expand access to preschool
  throughout the state. State licensing will create opportunities for outdoor preschool programs to
  leverage federal and local funding, including Preschool Promise, <u>Community Childcare Initiative</u>,
  work quality improvement system and quality recognition programs, Multnomah County's
  Preschool for All program, tribal funds for childcare, DELC grants like capacity expansion
  grants, and extended ERDC hours.
- 2. Outdoor preschools have long waitlists and are an increasingly popular option among families. Allowing families to choose outdoor preschool can help fill slots for subsidized programs like Preschool Promise and Preschool for All.

#### Providers:

- 1. Outdoor preschool licensure gives providers more insurance options.
- 2. Licensure offers alternative options in areas where indoor facilities appropriate for childcare are hard to find because of high rent or limited infrastructure. Outdoor preschools provide an alternative safe and high-quality option.
- 3. Licensure opens up training and funding currently unavailable to recorded programs, such as the Betty Gray Scholarship and Education Awards.
- 4. Outdoor preschool licensed providers can access higher education opportunities, which opens up more options for their training and ORO status.

#### Families:

1. Families can access childcare subsidies for outdoor programs, providing them with a cost-effective option for preschool. In addition, it meets Oregon's priority to offer more options for families.

#### Benefits of outdoor preschool

- 1. <u>Children benefit from outdoor preschool</u> through social and emotional learning, rich sensory experiences, and opportunities for building confidence, curiosity, and problem-solving skills.
- 2. Outdoor play <u>improves sleep in children ages two to five</u>, and we know that better sleep can enhance brain development for children.
- 3. Outdoor preschool increases self-regulation and executive functioning skills

In summary, outdoor preschool licensure is a cost-effective way to increase preschool access throughout Oregon. It provides opportunities for leveraging funding, insurance for providers, workforce development, higher education options for providers, and childcare subsidies for families. 
### Accessible

It's official: <a href="there's a severe shortage of preschool options">there's a severe shortage of preschool options</a> in Oregon. There's currently only capacity to serve 1 in every 5 young children who need child care throughout the state, and with physical space for child care centers limited, outdoor preschool provides an alternative that could help close that gap.

Providing a path to licensure for outdoor preschools would allow existing outdoor preschools to operate for full days and serve more children. It would help increase the state's capacity for child care by offering an alternative, accessible option for parents who need full-day care but are currently unable to access it.

Licensure also means low-income families and children enrolled in services such as Early Intervention will have access to outdoor preschool through subsidized systems that provide financial support, personalized coaching, and resources to the child's learning experience. Currently, many funding avenues and resources are unavailable to nonlicensed programs. Licensure offers equal access to outdoor educational spaces that will better support and empower children, families, and their caregivers.

# Licensed Outdoor Preschool is **Affordable**

In Oregon, the average annual cost of child care is over \$14,000, twice as expensive as public university tuition. Though both the state and federal governments offer childcare subsidies and waivers to help offset the costs of childcare, less than 1 in 5 Oregon children who qualify are actually enrolled in programs that accept these subsidies. When combined with the shortage of available preschool options throughout the state, many Oregon families aren't able to find an affordable solution to childcare, and our kids are the ones being left behind.

Outdoor preschools operate without the high costs associated with building rent and maintenance, utilities, etc. Lower building expenses mean that outdoor preschools can invest more money where it really matters: on hiring and retaining quality teachers and instructors to help facilitate your child's early learning.

# Licensed Outdoor Preschool is **Equitable**

Offering parents the power to choose where to send their children for preschool is a matter of equity. While several outdoor preschools already operate around the state, they aren't able to meet licensure requirements that were specifically designed with indoor spaces in mind. (For example, it's hard to ensure there aren't insects in the child's play area when the play area is a forest!)

No licensure option means these preschools can only operate for half days, and they are unable to accept state or federal child care resources or apply for programs like <u>Preschool Promise</u> or <u>Preschool for All</u>. This translates to outdoor preschools in Oregon being unavailable for families who rely on these programs, or who need to work full days and are unable to afford only half-day care.

Outdoor experiences are good for children's physical, cognitive, and social development in ways that are unique from a traditional indoor environment. Yet many families lack access to outdoor and nature-based experiences, and these inequities often fall across socioeconomic and racial lines. By licensing outdoor preschools, we're creating equitable and accessible opportunities for all families.

## What's the Solution?

In 2017, Washington passed SB 5357. The bill successfully established a four-year pilot project during which outdoor preschools operated for full days while working with state agencies and lawmakers to establish a path to licensure for outdoor preschools. In 2021, Washington became the first in the nation to permanently license outdoor, nature-based child care for preschool and school-age children under SB 5151. These bills addressed the same regulatory challenges that Oregon outdoor preschools face, and so we propose that Oregon pass an analogous bill or explore other policy pathways to licensure in 2023.
