Throughout my days so far, 20 more Riddle relatives have been added, of course saying our good-byes to some along the way. I plan to be buried on the Riddle Pioneer Cemetery hillside, amongst my family and friends. So you see, my roots are deep, and I could not be prouder to be a part of the Riddle Roots Community Projects and its vision to provide the Riddle Activity Center (RAC) to all of our Southern Douglas County communities.

Your support of our project is greatly desired. Our area needs a boost. Timber and mining have hit hard times over the years and supportive families have left in search of places that have more to offer. We want to provide that "more" right here in our own backyard. What a thing to be able to do! Children can walk across the street to the RAC after school to learn, play and connect to community. STEM programs can be offered to challenge and DIY workshops provided to young and old. All the while encouraging growth and vision for each individual to take with them either in their
