

Testimony in Support of HB 2098 -4

Co-Chairs Representative McLain, and Senator Frederick, Co-Vice Chairs Representative Boshart Davis, and Senator Boquist, Members of the Joint Committee on Transportation,

Dear Joint Committee on Transportation,

The Oregon State Building and Construction Trades Council is a statewide umbrella organization comprised of 31-member unions, representing tens of thousands of Union skilled trades workers across and around Oregon. The Council was formed in 1940 to bring together building-related trades to protect the welfare of workers and learn from one another and provide our members' voices here in the state legislature.

Today, we continue to work together to fight for local jobs that provide family-sustaining wages, hours, and safe working conditions. We also advocate for public and private investments to fund a broad array of infrastructure projects. By dedicating funding to roads and bridges, broadband, airports, energy infrastructure, and economic development opportunities in all communities across Oregon, we can create family-sustaining jobs, increase safety, and build ladders of opportunity for women and other underrepresented individuals that want careers in construction.

As the federal government contemplates investments in transportation projects of national significance, the Interstate Bridge spanning Oregon and Washington rises to the top. Our support for HB 2098 -4 amendment comes from over two decades of our efforts to replace the bridge and we must act now to be competitive for federal dollars.

This project offers an opportunity to expand and continue to diversify the construction workforce. The best way to ensure Oregon's investments are maximized is to apply strong labor standards to the project. We understand that prevailing wages will apply, but the Legislature can do more by requiring ODOT to partner with the Building Trades so we can ensure the values we hear expressed by many of you are reflected in the project implementation. Project Labor and Community Benefits Agreements are proven project delivery tools used by various federal, state, and local governments across the country to assure that workers from both urban and rural areas are provided family sustaining wages and benefits, safe working conditions, safety training, and contractors use and recruit a diverse workforce, as well as state registered apprentices. This is why we oppose the -2 amendment, as it would hinder competition by blocking stakeholders
