



## Overview

The Office of Enhancing Student Opportunities (OESO) selected abbreviated school day program placements as the 2022-23 emergent/emergency area for monitoring within Oregon's system of general supervision. As part of that selection, during the 2022-23 school year, OESO has required a monthly data submission for students receiving an abbreviated school day program for 30 or more school days. School districts throughout Oregon were directed to report students who are placed on or receiving an abbreviated school day program that has lasted longer than 30 school days. This document summarizes data submitted to OESO in March 2023.
