Hello Janice:

My apologies for not getting back to you sooner.

The month of January is very busy for me, coordinating the Board of Property Tax Appeals, Oregon Ethic Commission reporting, pushing out Special District Election information to all the districts in preparation for the May election, US Passport Services required special reporting and refresher training, just to name a few items I've been engaged with.

Now, back to the PRR; see some responses below in red.

After consulting with County Counsel, I have been advised that I will need to review all ballots for possible redactions that might reveal the identity of the voter.

So far I have devoted at least 4 hours to this request, locating and redacting information, unrelated to ballot review.

Relative to item 6, I price out the cost like this: Nov 2022 Gen. Elec. 10221 Ballots x 2, front and back = 20,442 images.

l estimate it will take 15 seconds to review each side of a ballot = 5,110.5 sec. Divided by 60= 85.175 hrs. @ \$40 per hour = \$3,406.40

The overall cost would be approximately \$3800.00.
