#### Work Session

SB 1047

Raises contract price threshold under which contracting agency may apply certain solicitation and procurement methods for public contracts.

SB 1048 \*\* \*\*Subsequent Referral(s) to Ways and Means Directs Department of Transportation to establish small business assistance program to assist qualified small businesses in competing for department's public improvement contracts.

### Public Hearing and Work Session

SB 571

Requires employer to offer contribution to ABLE account in lieu of contribution to retirement account.

SB 850

Requires public body that procures construction services for certain qualified projects that use \$750,000 or more in funds of public agency or moneys made available to state under federal American Rescue Plan Act of 2021 to enter into project labor agreement that, at minimum, provides for payment of wages at or above prevailing rate of wage, to use apprentices to perform at least 15 percent of work hours that workers in apprenticeable occupations perform on project and to establish and execute plan for outreach, recruitment and retention of women, minority individuals and veterans to perform work on project.

SB 851

Requires Bureau of Labor and Industries to study matters relating to psychological abuse occurring in workplaces in Oregon.

SB 907

Provides employee with right to refuse to perform task assigned by employer under certain circumstances.

SB 925

Makes unlawful practice for employer or employment agency to advertise job, promotion or transfer opportunity without disclosing pay range and employment benefits in job posting.

## AGENDA (cont.) March 28, 2023

#### SB 987

Requires Public Employees Retirement Board to study approaches to lowering employer contribution rate paid by charter schools under Public Employees Retirement System.

SB 30

Requires Bureau of Labor and Industries, in consultation with Employment Department to conduct study that identifies apprenticeship opportunities in this state and evaluates best practices for keeping up-to-date list of available opportunities on webpages of bureau and department.

SB 32

Permits Oregon Department of Administrative Services to study public contracting law. SB 33

Requires Bureau of Labor and Industries to study issues related to internal staffing at bureau. SB 34

Authorizes Oregon Business Development Department to survey state loan and grant programs for economic development.

SB 35

Permits Bureau of Labor and Industries to study issues relating to employment in this state. SB 36

Authorizes Director of Employment Department to study alternative arrangements by which employers may make tax payments required under unemployment insurance law.

SB 37

Permits Bureau of Labor and Industries to study issues relating to unlawful employment practices that occur in Oregon.

SB 52

Requires Bureau of Labor and Industries to study issues related to compliance with employment laws of this state.

SB 591

Requires Bureau of Labor and Industries to study issue of labor trafficking in this state.

SB 593

Requires Employment Department to study issues related to family and medical leave insurance program.

#### **Public Hearing**

SB 1067

Modifies definition of "employment relations" to exclude standards, requirements or procedures relating to body-worn cameras for purposes of law enforcement officer collective bargaining.
