


#### **CCO 101**

- In 2012, the Oregon State Legislature passed <u>SB 1580</u> authorizing Coordinated Care Organizations (CCOs) to achieve the Triple Aim of better health, better care and sustained costs
- CCOs are contracted with OHA to deliver Medicaid aka Oregon Health Plan (OHP) benefits
- In 2022, we celebrated the 10th anniversary of Oregon's coordinated care model

### **CCO 101**

- 1,501,589 Oregonians are on OHP and almost 92% (1,379,960) are enrolled in an CCO; 121,629 OHP members are on Open Card aka Fee for Service (<u>see OHA's May</u> <u>1st enrollment report</u>)
- CCOs receive a global budget to provide primary care, behavioral health, and oral health as well as social health needs and programs like non-emergent medication transportation (NEMT) that are integrated and coordinated
- CCOs and their provider network are subject to hundreds of reports, metrics, audits, and other deliverables for means of oversight, best practice identification, and areas for improvement
- Local community members and providers work with CCOs through their Community Advisory Councils, Governing Boards, and key deliverables like the Comprehensive Behavioral Health Plan and the Community Health Improvement Plan
