Measure Description:

Approves certain new or increased fees adopted by the Department of Public Safety Standards and Training.

Government Unit(s) Affected:

Department of Public Safety Standards and Training

Summary of Fiscal Impact:

Costs related to the measure may require budgetary action - See analysis.

Analysis:

ORS 291.055(1)(e) stipulates that all new state agency fees or fee increases adopted between the date of adjournment sine die of a regular session of the Legislative Assembly, and the date of adjournment sine die of the next regular session of the Legislative Assembly, are rescinded upon adjournment sine die of the next regular session of the Legislative Assembly unless the fee is authorized by enabling legislation.

ORS 181A.870 allows the Board on Public Safety Standards and Training, in collaboration with the Private Security and Investigator Policy Committee, to establish fees for issuing certifications and licenses to private security providers. The fees may not exceed the costs for administration of the certification and licensing program, the criminal records check, and any training program required by rule. The most recent change to these fees was 2011 when some fees were reduced, and some date back to 2005. This measure provides the enabling legislation necessary to approve fees adopted through administrative rule by the Board during the 2022-23 Interim. The Board administratively increased the following fees:

The Department of Public Safety Standards and Training anticipates the fee increases will generate approximately \$2 million of Other Funds revenue during the 2023-25 biennium based on the most recent 12-month average of licenses and certifications. However, this revenue will not be sufficient to operate the program and the Department will need to return to the Legislature in 2024 with further increases for the Private Security Professionals Program in addition to the fee establishment for Private Security Entities authorized in HB 2527 (2021) to adequately fund this program.
