Work Session

- HB 4049 ** **Subsequent Referral(s) to Ways and Means
Directs the Oregon State University Extension Service and the College of Agricultural Sciences of Oregon State University to study the fate and transport of perfluoroalkyl and polyfluoroalkyl substances (PFAS) found in biosolids applied to agricultural fields.
- HB 4061 ** **Subsequent Referral(s) to Ways and Means
Directs the State Department of Agriculture to establish an elk damage prevention and compensation pilot program.

Public Hearing

- HB 4128 ** **Subsequent Referral(s) to Ways and Means
Requires the Oregon Department of Administrative Services to study water infrastructure needs in this state and submit a report to the Legislative Assembly no later than September 15, 2025.
- HB 4059
Directs the State Department of Agriculture to study issues relating to brassica production in the Willamette Valley Protected District and report on the results to an appropriate committee or interim committee of the Legislative Assembly no later than September 15, 2025.
- HB 4090
Prohibits the Energy Facility Siting Council from exercising jurisdiction over or requiring a site certificate for an energy facility that is a renewable energy facility or transmission line, is sited wholly within federal lands and is subject to review under the National Environmental Policy Act.
