#### Work Session

- HB 4128 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Oregon Department of Administrative Services to study water infrastructure needs in this state and submit a report to the Legislative Assembly no later than September 15, 2025.
- HB 4059  
Directs the State Department of Agriculture to study issues relating to brassica production in the Willamette Valley Protected District and report on the results to an appropriate committee or interim committee of the Legislative Assembly no later than September 15, 2025.

#### Public Hearing and Work Session

- HB 4090  
CARRIED OVER FROM THE 2/13/2024 MEETING: Prohibits the Energy Facility Siting Council from exercising jurisdiction over or requiring a site certificate for an energy facility that is a renewable energy facility or transmission line, is sited wholly within federal lands and is subject to review under the National Environmental Policy Act.

#### Public Hearing

- HB 4106  
Directs the State Forester to establish sustainable harvest levels for harvesting timber on state forestland and develop a timber inventory model to inform sustainable harvest levels.
