- HB 4151 ** **Subsequent Referral(s) to Ways and Means
Digest: Makes a task force about youth behavioral health.
- HB 4081 ** **Subsequent Referral(s) to Ways and Means
Digest: The Act makes a program and an advisory board in the Oregon Health Authority to make it easier to get fast health care.
- HB 4070 ** **Subsequent Referral(s) to Ways and Means
Digest: The Act tells the OHA to adjust its school-based health center grants for inflation.
- HB 4091
Digest: The Act creates a committee to review proposed measures that require a health plan to pay for a certain type of health service or a health service that is provided by a certain type of provider of health care.
- HB 4003 ** **Subsequent Referral(s) to Ways and Means
Digest: The Act makes a state agency study the shortage of medical examiners in this state.
- HB 4150
Digest: The Act allows for some doctors or people like doctors to be told when a patient overdoses on a drug.
