HB 4092 ** **Subsequent Referral(s) to Ways and Means Requires the Oregon Health Authority to conduct a study to determine the funding required for each community mental health program to provide the services and perform the functions required by law related to individuals with behavioral health disorders in specified age groups.

HB 4010

Specifies that flavoring of a prescription drug is not compounding.

- 4011 ** HB **Subsequent Referral(s) to Ways and Means Prohibits cost-sharing on certain health insurance coverage of cervical cancer examinations.
- HB 4012 ** **Subsequent Referral(s) to Ways and Means Prohibits issuers of health benefit plans, health care service contractors or multiple employer welfare arrangements from requiring that drugs that are administered by a health care provider be dispensed at a certain pharmacy or by a pharmacy that is in the provider's network, under specified circumstances.
- HB 4149 ** **Subsequent Referral(s) to Ways and Means Requires pharmacy benefit managers to be licensed by the Department of Consumer and Business Services beginning January 1, 2025.
